1	A RESOLUTION relating to public safety; accepting a grant from the Department

7	WHEREAS Pierce County and the City jointly applied for these funds and		
8	pursuant to a memorandum of understanding will split the grant equally between		
9	the two jurisdictions, with each jurisdiction receiving \$134,340 of these funds, a		
10	WHEREAS the City will act as the lead agency for this grant and is		
11	responsible for accepting the award and signing the necessary certifications to		
12			
13	receive the funds, and		
14	WHEREAS the City will use its portion of the funds to purchase body worn		
15	cameras ("BWC") and docking stations for the Tacoma Police Department ("TPD"),		
16 17	subject to the development and implementation of BWC Policy and Procedures,		
18	and		
19	WHEREAS BWC are helpful in the documentation of evidence, officer		
20	training, preventing and resolving complaints brought by members of the public,		
21	and strengthening police transparency, performance, and accountability, and

23	WHEREAS in 2016, Project Peace was formed as a partnership between		
24	the TPD and the residents of the City, which outlines several initiatives for		
25	implementation within TPD to help foster better relationships between City		
26	residents and the TPD, and

1	WHEREAS, BWC are an important aspect of trust and legitimacy between	
2	law enforcement and the community they serve, and their purchase and use were	
3 4	included in these initiatives between TPD and Project Peace, and	
4 5	WHEREAS the City will also use the previous years' funding from the 2018	
6	and 2019 allocation to support the purchase of BWC, and	
7	WHEREAS as a requirement of the grant application, the City has made the	
8	application and the City's response available for the public to review and provide	
9 10	comments on the City's website under the Neighborhood and Community Services	
11	page; Now, Therefore,	
12	BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:	
13	Section 1. That the proper officers of the City are hereby authorized to	
14	accept a grant from the Department of Justice 2020 Edward Byrne Memorial
