GCB 3115 INTERLOCAL AGREEMENT Between WSDOT/City of Tacoma

Amendment No. 1

This Amendment No. 1 to GCB 3115 is made and entered into between the Washington State Department of Transportation (WSDOT) and the City of Tacoma (CITY); individually referred to as the "Party" and collectively referred to as the "Parties."

Recitals

- A. The Parties entered into Agreement No. GCB 3115 on April 15, 2019 in order to jointly establish a mutual and cooperative system to carry out their respective obligations of this Agreement for the construction of the Puget Sound Gateway Program (PROGRAM).
- B. The CITY will contribute additional funding for a shared-use path, the Hylebos Nature Area to Alexander Avenue E. segment for use as matching funds to a grant from the Puget Sound Regional Council's (PSRC) federal surface transportation program.
- C. Under Section 2 Payment, Subsection 2.3, both Parties agree to revise the Agreement for additional funds.

NOW THEREFORE, pursuant to chapter 39.34 RCW, the above recitals that are incorporated herein as if fully set forth below, and in consideration of the terms, conditions, covenants, and performances contained herein, the Parties agree as follows:

It Is Mutually Agreed As Follows:

- 1. Add to Section 1 a new subsection 1.5: "The Stage 1b portion of the project includes the construction of a shared-use path adjacent to SR 509 from Hylebos Nature Area to Alexander Avenue E. The project has received a One Million Twenty Thousand Five-hundred Thirty-one Dollars (\$1,020,531) grant from the PSRC federal Surface Transportation Program."
- 2. Add to Section 2 a new subsection 2.4: "The CITY agrees to contribute additional local funds of Two Hundred Thousand Dollars (\$200,000) to be used as matching funds to the PSRC grant for a segment of the shared-use path, Hylebos Nature Area to Alexander Avenue E."
- 3. Section 2.2 is hereby replaced in its entirety as follows:

WSDOT will invoice CITY for Stage $1a - SR\ 167\ /\ 70^{th}$ Avenue E. Vicinity Bridge Replacement Fivehundred Thousand Dollars (\$500,000) after the design-builder has notice to proceed (anticipated 2019). WSDOT will invoice CITY for Stage $1b - SR\ 167\ /\ I-5$ to $SR\ 509$ portion of construction in one payment of

Seven-hundred Thousand Dollars (\$700,000) beginning after the design-builder has notice to proceed (anticipated 2022) and two payments of Five-hundred thousand dollars in 2023 and 2024. The CITY will pay the invoice within thirty (30) days of receipt from WSDOT.

All other terms and conditions of this Agreement not changed by this Amendment remain in full force and effect.
