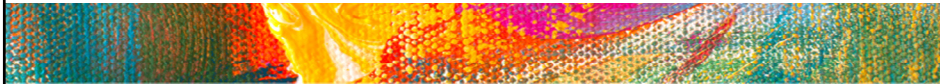

MOVED AND UPDATED FEES

- 62 fee amounts moved from TMC Chapter 3 to the Fee Schedule
- TFD will bring forward legislation to remove specific fees amounts from TMC
- Change is constant with other City processes, and allows easier updates
- Moves all non-construction related fees to one place
- Fee amounts inflated for CPI (1% 2021-2022)
- Lift assist, False alarm fees not changed

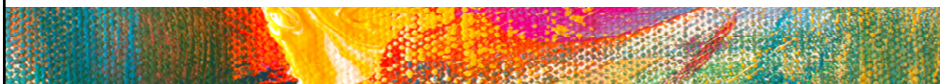
