SUBJECT: Federal Advocacy Contract

DATE: November 5, 2020

Council Member Lillian Hunter requested information on how much the City has spent for federal lobbying services in the past several years and how much federal funding we have received. The City of Tacoma has legislative advocacy needs in order to accomplish our policy and funding objectives at higher levels of government. At the federal level, this typically takes the form of advocacy on national policy regarding housing programs, immigrant detention, infrastructure funding, and more recently, funding to support local governments and special taxing districts during the COVID-19 pandemic. In order to effectively elevate our needs and concerns to members of Congress and the Presidential Administration, the City contracts with a lobbying firm based in Washington, D.C. to ensure that we are well-represented on the ground where crucial decisions are made.

Expenditures and Federal Funding Received

For the most recent two biennia (2017-2018 and 2019-2020), the total contracted amount for professional services provided by Simon and Company was \$293,936, an average \$73,484 per calendar year. Our contracts for services have also included a \$10,000 contingency amount for reimbursable expenses, such as transportation and printing costs incurred during mayoral and Council visits to Washington, D.C. During the six-year period beginning in January of 2015 through October of 2020, the federal government obligated \$125,630,679 for the City of Tacoma, either through direct grants or sub-awards from state agencies, such as the Washington State Department of Transportation, for projects and initiatives in Tacoma. This includes the \$4.6 million that the City received from provisions of the *CARES Act* this year.

The majority of federal funding that the City receives comes from three federal agencies: Department of Housing and Urban Development, Department of Justice, and Department of Commerce. These grants are crucial to the City's housing, public safety, and economic development efforts. Please see the table on the following page for a detailed breakdown of the grant awards by agency.

Services Provided by Simon and Company

Simon & Company assists the Government Relations Office with developing recommendations on federal priorities and provides all of the traditional lobbying services such as coordinating meetings with the congressional delegation, advocacy letters, and identifying grant opportunities that the City should pursue. In addition to these routine duties, the Simon & Company team provides other supportive services to the City. These include:

- Support for Mayor Woodards at the federal level: Coordinating the Mayor's itinerary for trips to Washington, D.C. in connection with the U.S. Conference of Mayors, serving as the primary point of contact and providing talking points and logistical preparation for speaking engagements and meetings. As Vice Chair of the Women Mayors Leadership Alliance, Mayor Woodards represents the City in many national-level events. In 2020, these included the "When All Women Vote" virtual civic engagement event hosted by former Obama administration advisor Valerie Jarrett, and the launch of the Civic Cities initiative hosted by Ms. Jarrett and former First Lady Michelle Obama. These supportive services are utilized throughout the year whenever needed.
- Support for City Council Members at the federal level: Coordinating itineraries for City Council Members for visits to Washington, D.C. and other locations in accordance with National League of Cities convenings, including scheduling and preparation materials for meetings.
- Liaison to federal agencies and the Administration: Simon & Company staff have established points of contact and relationships with federal agencies and can access those on demand when the City requires coordination or needs to gather information from the federal government. For example, in January of 2020, Simon & Company coordinated a meeting with a high-level official in Immigration and Customs Enforcement for Mayor Woodards to coincide with her scheduled trip to Washington, D.C. This meeting provided an avenue to express the City's concern for health and wellbeing of detainees at the Northwest ICE Processing Center and to identify ways to improve communication between the agency and City staff.

The firm also represents Metro Parks Tacoma, Tacoma Public Schools, Pierce Transit, and the Washington State Transit Association, which has allowed for strong coordination and synergy of efforts.

On October 29, 2019, the Tacoma City Council adopted Ordinance 28623, which authorized a \$2.82 per customer per month surcharge starting January 1, 2020 to cover the increased cost of processing, marketing, and shipping of recyclable materials. In addition to covering the increased cost of processing and selling those materials, \$0.50 of the monthly surcharge was authorized to establish more funding for education and outreach to residential (single family home or duplex) customers. The funding generated through the surcharge to cover increased cost for processing, marketing, and shipping recyclables is set to be reexamined by December 31, 2022. The funding generated through the surcharge to support increased education and outreach is scheduled to sunset on December 31, 2023.

In addition to Ordinance 28623, City Council also unanimously approved Resolution 40461, which established the "Recycle Reset Project" as a special project and authorized the hiring of unbudgeted staff to support increased education and outreach. The Recycle Reset Project focuses on two main goals related to education and outreach which are:

- 1. Ensure that all residential customers are aware of the surcharge, changes to the recycling program, and updated information regarding accepted materials
- 2. Reduce contamination in the residential recycling stream

Recycling market update:

In the City of Tacoma's Year End Report, prepared by Waste Management/JMK Fibers' Senior Material Recovery Facility Manager, Mike Range, describes 2019 as "showing how fragile and volatile recycling markets are with China, Vietnam, Indonesia, and numerous other countries bowing out of the market." In addition to the volatile international markets, there has been increased international scrutiny on the environmental justice impacts of shipping recyclables and waste to countries that are not able to process these enormous amounts of materials, especially in regards to plastics. This has forced Waste Management/JMK Fibers and others to identify domestic markets for processing recyclables into new materials.

Currently, Waste Management/JMK Fibers is processing, marketing, and shipping materials almost entirely domestically in North America. The exception to this is with mixed paper, of which the majority is sold in Asia. Waste Management/JMK Fibers hopes to process completely domestically in the near future, but it takes time to develop the infrastructure necessary to process the large amount a mixed paper within Washington.

Recycling prices update:

Although there have been some modest upward trends in the market for some materials (e.g. Natural HDPE), most recyclable materials are still being sold at a loss. This is especially true for cardboard and mixed paper, which typically makes up over 75% of Tacoma's recycling stream. For comparison, please see Table 1 that compares the market prices per ton for materials from September 2019 to that of September 2020.

Table 1 identifies that although some materials have seen an increase in their market price, Solid Waste Management still owes \$89,975.46 to Waste Management/JMK Fibers for the processing, marketing, and shipping of materials for September 2020. Individual material costs fluctuate widely, so it is important to look at the costs of the entire mix of the materials. In September 2019 the City paid \$93.80 per ton as compared to \$77.80 per ton in September 2020, which is a difference of \$16 per ton. Although this is a step in the right direction, it is nowhere near the City's revenue of around \$100 per ton, prior to China implementing its National Sword policy in 2018. This policy banned the import of most paper and plastic recycled material to China, which had major impacts on the international recycling market as they were the largest imported of recyclables. China's policy change also included new more stringent contamination requirements for imported recyclables of less than 1 percent. China implemented this policy, currently known as Blue Sky, to address pollution issues.

Based on the 2019 Year End Report from Waste Management/JMK Fibers, they do not anticipate that these prices will dramatically increase anytime in the near future. In the report, Waste Management/JMK Fibers sees the main strategies in reducing inbound contamination to the processing facility as continued education and outreach to customers that encourages only placing accepted items in the recycling bin and emphasizing quality (empty, clean, and dry) over quantity.

Solid Waste Management recommendation:

Given the volatile markets, time and resources it takes to develop new domestic markets, the costs of processing cardboard and mixed paper, and the City's processor emphasizing increased education and outreach as the main strategy to reduce inbound contamination, Solid Waste Management recommends maintaining the Recycle Reset surcharge through at least the end of 2021.

SUBJECT: Home In Tacoma Project **DATE:** November 10, 2020

OVERVIEW:

Tacoma residents face increasing challenges in accessing housing they can afford that meets their needs. One part of the solution is to create more homes for more people. As part of implementation of the Affordable Housing Action Strategy (AHAS), this project will present the City Council with options to modify Tacoma's housing growth strategy and zoning to allow a broader range of housing types in Tacoma's predominately single-family neighborhoods. The project will also modify Tacoma's affordable housing incentives, bonuses and requirements to promote affordability and mitigate displacement risk in more rapidly growing areas.

Project goals: Promote housing supply, affordability and choice

Actions: Modify Tacoma's housing growth strategy

- Continue to grow and promote affordability in centers and corridors
- Promote infill in single-family/low-density neighborhoods

Key considerations:

- Equity, empowerment and antiracism
- Healthy, resilient and climate-friendly development
- Walkable and transit-supportive neighborhoods
- Urban design and fit with neighborhood patterns
- Understand infrastructure and urban services
- Market feasibility
- Avoid unintended consequences
- Reflect community input

DISCUSSION:

At the study session on November 10, 2020, staff will request City Council guidance on potential outcomes of the project. To start the discussion, staff request input on the following questions:

- What missing middle housing types should be allowed in established neighborhoods?
- What design features are critical to ensuring that infill is compatible with neighborhood patterns?
- What potential impacts of infill are of the most concern?
- What would give you enough confidence in Tacoma's housing market to be comfortable expanding affordability requirements?

POLICY DIRECTION:

The City Council has adopted multiple policies that guide this effort, including:

- Affordable Housing Action Strategy
- One Tacoma Comprehensive Plan Housing Element
- Tacoma 2025 Strategic Plan
- Antiracism Transformation (Resolution No. 40622)
- Equity and Empowerment Framework and Equity Index

These City Council actions provide clear direction to modify Tacoma's housing growth strategy to better meet housing needs, make access to housing and opportunities more equitable, address disproportionate impacts to people of color, and accommodate growth in walkable, sustainable neighborhoods.

As directed by Ordinance No. 28695 (adopting <u>Infill Pilot 2.0</u>), the schedule is to provide Comprehensive Plan amendments for City Council consideration <u>by May 2021</u>, and a full package of implementing zoning changes, along with appropriate standards and processes, for City Council consideration <u>by December 2021</u>.

ENGAGEMENT:

Tacoma's Planning Commission is asking the community to join in a discussion about housing needs, development trends, zoning, and neighborhood change. The Home In Tacoma Project webpage is the forum to learn about the project through an infill video, project storymap and online café series, and to provide input through a community survey.

The Commission has directed that their efforts be informed by both broad community engagement, and targeted engagement with key stakeholder groups:

- The housing development community are essential partners and hold expertise that is critical to the success of this effort. The AHAS Technical Advisory Group, a Developer Focus Group and City departments are providing input.
- Lower-income residents and people of color are particularly impacted by housing decisions, yet have typically been under-represented in land use decisions. The Human Rights Commission and Planning Commission have jointly formed the *Housing Equity Taskforce* to guide engagement and make recommendations to achieve equity and antiracism goals.
- City Commissions including the *Landmarks Preservation Commission, Sustainable Tacoma Commission* and *Transportation Commission*, as well as business and neighborhood groups will provide input on topics that are closely related to housing.

Using community ideas and feedback, and input from key stakeholder groups, the Planning Commission will formulate recommendations guided by the City Council's policy direction to date.

PROPOSED ACTIONS:


Diversify housing types: Promote mid-scale housing types, such as two and three-family attached housing and low-scale multifamily, in more areas of the City.

Allowing mid-scale housing types can increase housing supply, affordability and choice in existing neighborhoods. The majority of Tacoma's housing land supply is currently set aside for single-family detached housing, with space for large-scale multifamily housing in centers and corridors. There is limited space where mid-scale housing types are encouraged, which is why these types are referred to as "missing middle housing". This effort expands upon recent missing middle actions like allowing accessory dwelling units and the Infill Pilot Program.

Promote affordable housing: Use incentives and bonuses to increase the number of affordable housing units built in areas where growth is happening more quickly.

Affordability incentives, bonuses or requirements can increase dedicated affordable housing supply and help combat displacement. The City can offer bonuses, such as allowing more units or reducing parking requirements, to encourage developers to include affordable units in larger housing projects. Tacoma will revisit its current package of incentives and bonuses to make them more effective in meeting affordability and anti-displacement goals.

Missing middle housing generally ranges from duplexes up to low-density multifamily housing types (<u>circled in blue</u>). Affordable housing incentives and bonuses are generally used with medium to high-density housing types (<u>circled in red</u>).


APPLICABILITY:
