Briefing Items

20-0569 Urban Food Security through Trees and Urban Agriculture on Public Lands
 [Jim Parvey, Division Manager; Mike Carey, Urban Forester, Office of Environmental

Policy and Sustainability]

At approximately 4:33 p.m., Jim Parvey, Division Manager, Office of Environmental Policy and Sustainability (OEPS), introduced Pat Babbitt, Project Specialist, and Ryan Hebert, Management Analyst I, OEPS. Together,

they presented an update on urban food security through trees and urban agriculture on public lands, including an overview; policy review; issues; potential opportunities; learning from other municipalities, noting Seattle, Washington and Culver City, California; using public lands to grow food; food producing trees; the Tacoma Urban Farm pilot; and next steps.

Discussion ensued regarding barriers to urban agriculture, the Food is Free movement, personal gardens in the right-of-way (ROW), possible issues or barriers to gardening in the ROW, what is allowed to be planted in the ROW, providing fruit trees to homeowners, care and maintenance of the ROW, partnering with Tacoma Public Schools to create school programming, connecting food grown with those in need, the Gleaning Program, food donated this year, simplifying the permitting process, and next steps.

3. 20-0570 Safe Routes to School Action Plan Update
[Carrie Wilhelme, Safe Routes to School Coordinator, Public Works]

At approximately 5:28 p.m., Carrie Wilhelme, Safe Routes to School Coordinator, Public Works, presented the Safe Routes to School (SRTS) Action Plan update, including purpose; background; engineering, noting accomplishments, both underway and completed, and other projects that support SRTS; education, noting accomplishments and University of Washington Tacoma walk audits; encouragement and enforcement accomplishments; funding; and next steps.

Discussion ensued regarding sending reminders to families on walking to schools, funding public safety programs, funding sources for the school guard crossing program and how other school districts fund similar programs, and changing behavior around speeding using mechanisms such as speeding cameras.
