

Commissioners voted for the Chair position as follows:

Rosie Ayala (10 votes), Michael Kula (3 votes), Ben Maestas (1 vote), and James Stowe (0 votes)

Commissioners voted for the Vice Chair position as follows:

Michael Kula (4 votes), Ben Maestas (9 votes), and James Stowe (1 vote)

Staff gave an overview of the estimated funding available for distribution in 2021-2022 and a proposed redistribution breakdown between the Community Arts Projects and Tacoma Artists Initiative Program funding programs. Staff estimated that there would be \$300,000 in funding to re-distribute. Commissioners discussed and asked questions before deciding on the following:
