BRIEFING ITEM

1. <u>21-0009</u> To discuss the appointment of a Chief of the Tacoma Police Department

At approximately 9:26 p.m., City Manager Elizabeth Pauli provided an update on the Chief of the Tacoma Police Department (TPD) recruitment process, including appreciation for staff, community members, and City Council Members who participated in the process; the decision to appoint Mike Ake, Assistant Chief, as Interim Chief for the TPD; reasons for the decision, noting ongoing transformation efforts, Assistant Chief Ake's qualifications, recruitment limitations related to the COVID-19 pandemic, community concerns, and immediate and long-term transformation goals.

Discussion ensued regarding support for the decision, community involvement and feedback, the recruitment process, internal versus external candidates, the City Council's role in appointing an Interim Police Chief, the continued focus on transformation, acknowledging outgoing Police Chief Don Ramsdell, interactions with the Community's Police Advisory Committee, work by 21CP Solutions consultants, recognition of TPD staff, and next steps.

City Manager Pauli concluded by introducing Assistant Chief Ake, noting his demonstrated investment in transformation and leadership qualities. Assistant Chief Ake made remarks thanking the City Council for their support and looking forward to the new role as Interim Police Chief.
