## **ORDINANCE NO. 28732**

AN ORDINANCE related to the vacation of City right-of-way; vacating that portion of East "K" Street, and an adjoining alley, lying between East 26th Street and East Wiley Avenue and westerly of East "L" Street, for business development and expansion; and adopting the Hearing Examiner's Findings, Conclusions, and Recommendations related thereto. WHEREAS all steps and proceedings required by law and by resolution of the City Council to vacate the portion of the right-of-way hereinafter described have been duly taken and performed; Now, Therefore,

BE IT ORDAINED BY THE CITY OF TACOMA:
