Overview of Substitute Ordinance #28624

- Adopted on November 12th, 2019
- Imposed tax on businesses making retail sales of firearms and ammunition starting July 1, 2020
 - \$25 per firearm sold
 - \$0.02 per round of ammunition for .22 caliber or less
 - \$0.05 per round of ammunition for all others
 - Estimated \$30,000 in annual revenue
- Directed City Manager to make recommendations and review impacts of tax, its revenues, research best practices, and convene workgroup

Updates to City Council

In February, City Staff shared with City Council recommendations and met with Community Vitality and Safety Committee (CVS) on:

- Potential partnerships and engagement
- Programs to reduce youth violence
- Evaluation of gun buyback program (not to proceed)
- Shared ways City would work to reduce gun violence through local, state, and federal legislative efforts



Updates to City Council

In May, City Staff consulted with City Council and shared inability to complete the following ordinance requests due to COVID-19 Emergency:

- Hire consultant to convene workgroups to include representatives from TPS, Tacoma based firearms manufacturers and retailers, community partners, City Staff (to include TPD) – (\$10 -\$15K)
- Hire consultant to review best practices to address gun and youth violence reduction - (\$10-\$15K)

July 1, 2020 - Ordinance #28677

Due to inability to meet all ordinance requirements due to COVID-19 Emergency, City Council:

- 1. Changed effective date of tax to a date to-be-determined
- 2. Set January 2021 for discussion on next steps and reviewing recommendations for new timelines for gathering information, conducting community and stakeholder outreach, and reports to City Council
