5. Planning and Development Services (PDS) Director Peter Huffman provides the **attached memorandum regarding the SeaPort Sound Plant Modernization project. On February 4, 2021, Planning and Development Services (PDS) will be issuing an Environmental Determination of Significance for the SEPA/Shoreline review of LU20-0107, SeaPort Sound Plant Modernization project.** This will initiate the Environmental Impact Statement process for the project.

6. **DRAFT Homeless Strategy**: Neighborhood and Community Services will present to the Tacoma-Pierce County Coalition to End Homelessness on Friday, February, 5, on the **DRAFT framework for the City's homelessness strategy**. **NCS will invite the Coalition to engage in direct feedback as well as help the department identify a process for community outreach that engages individuals with lived experience, BIPOC community members and homeless service providers.** The draft homeless strategy has six main areas of focus:
- Racial disparities in homelessness
 - Street outreach
 - Homelessness prevention
 - Emergency shelter
 - Housing
 - Mental Health and Substance Use Disorder

Friday's conversation will be the first in an ongoing series of feedback sessions with the Coalition. Council will receive an overview of the strategy and the engagement process at the February 23 Study Session.

7. **Rental Assistance Update**: The City recently received notification of receipt of just over \$6.5 Million in U.S. Department of Treasury funds to support Emergency Rental Assistance. **City staff is working with the County to streamline the application process for residents and Council will receive an update as details are available. Council will receive a briefing on the City's approach at the February 9 Study Session.** To date, the City's emergency rental assistance program has served a total of 638 households with awards totaling \$902,538.06. The City's Rental Assistance Fund at the Greater Tacoma Community Foundation has received 25 gifts totaling \$28,820.

8. **Warming Center Updates**:

- **Eastside Community Center**: The temporary warming center at the **Eastside Community Center continues to operate at capacity with 55 individuals staying overnight each night, with an average of 21 additional individuals accessing daytime services each day.** Staff continues to work to connect individuals to services. This location will operate until February 28, 2021.
- **The Center at Norpoint**: The Center at Norpoint opened as a temporary warming center on Tuesday, January 26. **The site has a capacity of 25 individuals, serving adult women and couples. Through the first week of operations, there were a maximum of 6 individuals staying overnight.** Site staff continues to work with shelter providers and community partners to increase referrals to the site. This location will operate until February 28, 2021.
- **Salvation Army**: The Salvation Army building at 1110 S. Puget Sound is beginning operations as a temporary warming center today, January 28th. **This location serves men and has a capacity of 35 individuals and served three individuals each evening from 1/28/21-2/2/21.** The location will operate through March 31, 2021.

9. Senior Meal Delivery: **Access to healthy meals is important to our senior population and the City has adjusted contracted services during the COVID-19 pandemic to ensure seniors can still access food while senior centers are not operating.** The City's contracted partner ensured pickup and delivery of 353 meals for the week of 1/25 - 1/29/21.

SUMMARY AND PURPOSE:

A resolution authorizing 2021 membership in South Sound Together, in the amount of \$12,000, budgeted from the Council Contingency Fund.

BACKGROUND:

South Sound Together (SST) is a community-focused group of business and institutional leaders that promote the South Puget Sound as a good place for business and a great place to live. By bringing together key leaders from across the region and leveraging our investment of time and resources, South Sound Together aims to advance community and economic goals and tell the region's story. South Sound Together formed in 2015 and has undertaken a number of initiatives to showcase the South Sound -0 since that time, including the 'Live Like the Mountain's Out' campaign. The initiative's ongoing goals include engaging in partnerships and building community that will positively impact the lifestyle and economy of South Sound.

The initiative was originally hosted and facilitated by the Tacoma News Tribune. In 2020, South Sound Together transitioned operations from The News Tribune, recommitted to community projects, and registered as a nonprofit corporation in Washington State. Greater Tacoma Community Foundation has been engaged as a fiscal agent for SST and holds their monetary assets.

Building on the South Sound Proud brand and past campaign success, SST will launch 'Proud Moments' throughout the South Sound in the spring of 2021.

A \$12,000 sponsorship/membership would provide the City with:

- A seat on the South Sound Together 2021 Board (to be filled by the Community & Economic Development Director or their delegate)
- Sponsorship of a non-profit to join the South Sound Together Board for a year
- Help steer the direction of the 2021 projects
- Inclusion in all presentations, promotions and marketing, including South Sound Together social media and South Sound Proud website

In fall 2020, the South Sound Together Executive Board created a list of non-profits to invite based on past participation and 2021 priorities (youth engagement, broader county engagement, sector diversification). The Board prioritized that list at their December meeting and then invited participation on a rolling basis as 2021 memberships were secured. To date,



SST will include the following sponsored organizations: United Way of Pierce County, Bates Technical College, Tacoma Community College, Tacoma Urban League, and Tacoma Arts Live. Others are under consideration.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

South Sound Together plans and implements regional initiatives based on direction from a board that includes a collection of voices from business and non-profit leadership. Membership can be evaluated annually upon renewal for the value it adds to the City of Tacoma and how it takes into account the input of and impact on underrepresented communities' input.

2025 STRATEGIC PRIORITIES:

South Sound Together implements regional initiatives based on direction from a board that includes a collection of voices from business and non-profit leadership. 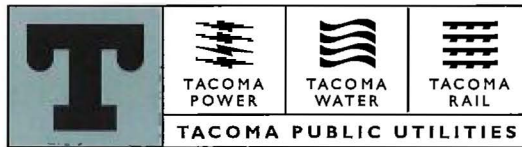

SUBJECT: January 2021 Neighborhood Council Liaison Report

SUMMARY:

The purpose of this memo is to provide a summary of topics and concerns discussed at the eight neighborhood councils and the Community Council of Tacoma during the month of January 2021. These items have been identified by the City Manager's Office liaison to each council as important or useful to bring to the City Council and City Manager's attention.

The Neighborhood Councils are working to organize a large effort for the Litter 253 clean up event on April 17th. Glass drop-off sites were also discussed at several meetings. NCs have also been asked to submit their 2020 Annual Report in order to receive \$4000 in funding for the 2021-2020 fiscal year.

Questions regarding the Neighborhood Councils can be directed to the Program Coordinator at NeighborhoodCouncils@cityoftacoma.org.

TOPICS and CONCERNS:

Community Council of Tacoma: Representatives may begin working with City staff to receive trainings to potentially lower their liability insurance, which currently accounts for about 20% of NCs' respective budgets.

South Tacoma Neighborhood Council: A bank property was purchased and will soon be redeveloped.

South End Neighborhood Council: Concerns were raised desiring more housing across Pierce County. They are closely tracking the Food is Free 253 project.

North End Neighborhood Council: No concerns were discussed, but they did hear a presentation on Home in Tacoma. The Planning Department has expressed that they'd like to do similar presentations at other NCs.



New Tacoma Neighborhood Council: No concerns were raised. The meeting was just staff presentations. The NC is discussing what they'd like to do in 2021.

Northeast Tacoma Neighborhood Council: Concerns were raised about guardrails on Northwest Parkway and at 509 and Alexander. Potholes were also a concern, as well as speed beacons on Nassau Avenue near Meeker.

West End Neighborhood Council: Residents were pleased with the micro-shelter on 6th and Orchard and reported good relations between it and the retirement home nearby. Concerns were raised about what would happen to vacant Safeway and K-Mart properties in the neighborhood.

East Tacoma Neighborhood Council: Various questions were brought up regarding the status of Public Works projects. Public Works is following up.

Central Tacoma Neighborhood Council: Liaison reports were videotaped prior to the meeting and were shown in a compilation for the meeting rather than an interactive format. No issues to report.

DATE: February 2, 2021

OVERVIEW:

On February 4, 2021, Planning and Development Services (PDS) will be issuing an Environmental Determination of Significance (DS) for the SEPA/Shoreline review of LU20-0107, SeaPort Sound Plant Modernization project. This will initiate the Environmental Impact Statement (EIS) process for the project.

BACKGROUND:

SeaPort Sound Terminal, LLC (SeaPort Sound) is proposing to demolish existing refinery equipment and replace it with new storage tanks and appurtenances at the SeaPort Sound Terminal located on the Hylebos Waterway at 2628 Marine View Drive in Tacoma. The SeaPort Sound Plant Modernization Project (Project) includes demolition of existing refinery equipment, installation of new storage tanks and containment system, as well as wastewater and stormwater improvements. The purpose of the Project is to replace aging refinery infrastructure with new storage tanks and associated safety and environmental protection measures to meet functional, operational, and environmental needs at the terminal.

The current storage capacity in the refinery area is approximately 15,000 barrels; the new tanks would have a capacity of about 181,000 barrels of diesel, bio-diesel, and other fuel oils. The storage increase is roughly a 10 percent increase over the full capacity at the site. The applicant is not seeking an increase in the overall total amount of product processed through the facility.

PDS initially issued a preliminary Determination of Nonsignificance in August 2020. Based on public comment, and on the provisions of the Washington Administrative Code, PDS is withdrawing that preliminary determination and issuing a Determination of Significance.

PDS has determined this proposal is likely to have a significant adverse impact on the environment and an EIS is required. This determination is based upon the unknown and probable significant adverse impacts from the increased storage of fossil fuels in a location that is proximate to human habitation, that is adjacent to sensitive critical habitat, and that is subject to liquefaction and other seismic risks.

PDS has identified the following areas for discussion in the EIS: emergency response, risks to public safety, intelligent transportation systems for emergency access, spill prevention and response, and air quality – to include the life cycle greenhouse gas emissions from the additional products to be stored on the site.

SCOPING:

Agencies, affected tribes, and members of the public will be invited to comment on the scope of the EIS. PDS will use the scoping comments, as well as comments on the preliminary SEPA determination, to define the topics to be examined closely in the project EIS. All comments are due no later than February 25, 2021.

An EIS public scoping meeting is scheduled to begin at 6:00 p.m. on February 18, 2021, via Zoom. The purpose of the public scoping meeting is to provide information about the proposed project and to provide an opportunity to comment on the scope of the proposed EIS. Comments will be accepted at the meeting but written comments are encouraged.

EFFECT OF A DETERMINATION OF SIGNIFICANCE:

The DS compels the City to conduct an EIS for the proposal. The EIS is a thorough study of the action (in this case, issuance of development permits) and its probable impacts.

The EIS will be prepared by the applicant per the specifications of PDS (including any additional scoping comments), with public and agency review and commenting once the draft EIS is issued. The EIS provides impartial discussion of impacts and informs the decision makers of any reasonable alternatives, including mitigation. This EIS is not expected to be broad in scope. Overall, however, the EIS enables government, the Puyallup Tribe of Indians, and interested residents to review and comment on permit issuance for the SeaPort project.

Following an EIS, the City may approve, approve with conditions, or deny the proposal based upon its environmental impacts.

I ask for your support for a Council Contingency Fund expenditure.

LEGISLATIVE INTENT:

Council Contingency Fund Request: That \$6,000 be contributed by the City of Tacoma towards a Joint Municipal Action Committee (JMAC) sponsored RFP to provide consulting services to the group to better align the work of participating organizations and to run from January 25, 2021 through June 30, 2021. The total cost of the RFP (\$30,000) is to be shared among participating organizations (City of Tacoma, Pierce County, Metro Parks, Tacoma Public Schools, and the Port of Tacoma).

Background: Policymakers from JMAC discussed the problem of systematic racism being present in governmental systems and wishes to reimagine what a more equitable and anti-racist community looks like. The collective's current goal is to jointly plan, coordinate, and implement community initiatives and to avoid stand-alone efforts. This project aims to: 1) solicit outside expertise to facilitate discussions on how to use the COVID-19 pandemic as a catalyst to identify and prioritize collaborative opportunities; 2) develop "common language" and expectations between policymakers and staff to enable JMAC to work more effectively and efficiently; and 3) develop a process that illustrates how multiple public jurisdictions can better serve the same residents by better integrating projects and initiatives for greater collective impact and increased sustainability. The City's Heal the Heart of Tacoma will be used as a guide to leverage and apply the best collective impact approach to JMAC's project.

Deliverables include the following:

- Development of a new governance doctrine that defines roles and responsibilities, establishes a model for governing, and clarifies the relationship between JMAC and Tacoma area public agencies.
- Development and implementation of a pilot project that bolsters the collective JMAC capacity, aligns existing resources, and demonstrates an equitable approach.
- An asset map of community reform efforts and COVID-19 opportunities and constraints.
- The convening of an event among regional leaders to consolidate knowledge from the assessment and take stock of what it reveals.

Problem Statement: The problem to be solved is a lack of clear cohesion among participating JMAC organizations on how best to work together to promote the health and safety of residents with a racial-equity lens and to identify where the mutually beneficial, multi-jurisdictional opportunities reside.
