### SUMMARY:

A resolution appointing, reappointing, and ratifying individuals and all actions and decisions made by the Citizen Commission on Elected Salaries for the years 2017 through 2020.

### **STRATEGIC POLICY PRIORITY:**

Appointing individuals to the Commission best aligns with the strategic priority policy related to encouraging and promoting an open, effective, results-oriented organization by establishing a Citizen Commission on Elected Salaries to determine Mayor and Councilmember salaries.

### **BACKGROUND:**

The Citizen Commission on Elected Salaries consists of seven members appointed as follows: Five of the seven Commission Members shall be selected by lot by the Pierce County Auditor from among those registered City of Tacoma voters eligible to vote at the time the persons are selected for appointment to the Commission. One member will be selected from each of the City's Council districts. The Auditor shall establish policies and procedures for conducting the selection by lot to be forwarded to the City Council for appointment. The remaining two of the seven Commission members must be residents of the City of Tacoma and shall be appointed by the Mayor and confirmed by the Council. One person shall have experience in human resource management and the second person shall have experience in legal profession.

The Mayor recommends the reappointment of Richard Wilkinson to the position of HR Specialist to the Commission for a term to expire September 30, 2022. The Pierce County Auditor has selected by lottery the following names for nomination and confirmation of appointment. By ratifying the members and their terms listed below, the Commission will be current on record.
