### **ORDINANCE NO. 28729**

AN ORDINANCE relating to the Building and Plumbing Codes; amending 1 Chapters 2.02 and 2.06 of the Tacoma Municipal Code, relating to the 2 Building and Plumbing Codes, to repeal existing sections and incorporate new provisions to align with Washington State adoption of changes to 3 state building codes, to become effective February 8, 2021. 4 WHEREAS building codes establish minimum standards for the construction 5 of buildings and structures, including building access, restrooms, parking, and 6 7 other areas surrounding the building, and 8 WHEREAS, at the direction of the Washington State Legislature, the 9 Washington State Building Code Council develops amendments to building codes 10 which set minimum building and fire protection standards throughout Washington 11 State, including the 2018 International Building Code, 2018 International 12 Residential Code, 2018 International Existing Building Code, 2018 Uniform 13 14 Plumbing Code, 2018 International Mechanical Code, 2018 International Fuel Gas 15 Code, and 2018 International Fire Code, and 16 WHEREAS the state allows local jurisdictions to amend these codes with 17 requirements which are specific to the needs of that particular community and do 18 19 not diminish the minimum requirements, and 20 WHEREAS Planning and Development Services ("PDS") staff is proposing 21 amendments to Tacoma Municipal Code ("TMC") Chapter 2.02, Building Code, 22 and Chapter 2.06, Plumbing Code, which are intended to streamline local codes, 23 increase clarity and alignment with state building code requirements, and enhance 24 25 usability of existing buildings, and 26




