At approximately 4:39 p.m., Doris Sorum, City Clerk, informed the Committee they will be interviewing two applicants for the Board of Building Appeals, and that there are two positions available on the Board, including the Mechanical Engineer and Structural Engineer positions. Chair McCarthy provided background regarding the Board and other positions.

Discussion ensued regarding applicant eligibility.

4. [21-0058](#) Landmarks Preservation Commission Recommendation for Historic Designation of 201 North Yakima Avenue
[Reuben McKnight, Historic Preservation Officer, Planning and Development Services]

At approximately 5:01 p.m., Reuben McKnight, Historic Preservation Officer, Planning and Development Services, introduced Kevin Bartoy, Chair, Landmarks Preservation Commission (LPC); Marshall McClintock, Member, and Michael Sullivan, Advisor, Board of Historic Tacoma; Jessica Clawson, Attorney, McCullough Hill Leary; and Ellen Mirro, Architectural Historian, Studio TJP. Mr. McKnight presented the LPC recommendations to place 201 North Yakima Avenue, known as the Wahlgren Florist Shop, onto the Tacoma Register of Historic Places, including an overview; background; issues; a health, equity, and sustainability analysis; outreach, noting public comments; next steps; and recommendations.

Together, Ms. Clawson and Ms. Mirro presented the property owner's protests, including background, landmark criteria, threshold criteria, and designation criteria.

Together, Mr. McClintock and Mr. Sullivan presented Historic Tacoma's agreements with the LPC recommendations, including building integrity, associations with Tacoma's history and communities, possibilities for

development next to the parcel, and recognizing historical stories and their relevance to Tacoma.

Discussion ensued throughout regarding the nomination process and LPC research process, history of the Wahlgren building, original building details versus those that were remodeled, possible compromises within a Mixed-Use Center context, use requirements if the building is put on the registry, construction plans if the building is not put on the registry, demolition of historic landmarks, incorporating historic landmarks into Mixed-Use Centers, why the Wahlgren building was nominated, potential development of housing at the site, and getting input from the full City Council.

MOTION: Chair McCarthy moved to confer with the recommendations of the Landmarks Preservation Commission and forward them to the full City Council for consideration.

SECONDED BY: Council Member Walker.

ACTION: Voice vote was taken and carried. The motion was declared adopted.
