SUMMARY AND PURPOSE:

A resolution authorizing the execution of non-exclusive perpetual easement to the Metropolitan Park District of Tacoma, for a Park Easement and Sewer Easement covered under City easement number E-4526.

BACKGROUND:

Metro Parks acquired the benefitting property in 2020 with the specific intent of developing Melanie Jan LaPlant Dressel Park. In order to make the planned park improvements, two easements are needed from the City. These two easements within the singular easement document will provide a non-exclusive perpetual easement to install, construct, operate, inspect, maintain, remove, repair, and replace park and sewer system improvements. The work will minimally impact the City property.

COMMUNITY ENGAGEMENT/CUSTOMER RESEARCH:

The design for the park went through a community engagement process for schematic design and design development with the City and Metro Parks.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

The easement will help facilitate another park/restroom in the area, which is a public benefit. The new restroom will limit the distance between park facilities by closing the gap to approximately a 10-minute walk.

Livability: *Equity Index Score*: Moderate Opportunity.

Improve access and proximity by residents to diverse income levels and race/ethnicity to community facilities, services, infrastructure, and employment.
