SUMMARY AND PURPOSE:

An ordinance reclassifying the illegal use of fireworks from a Class 2 civil infraction to a Class 1 civil infraction, effective immediately, to promote public safety through strengthening the legal deterrent.



BACKGROUND:

The illegal use of fireworks in Tacoma, particularly around the July 4th holiday, creates a dangerous fire hazard - threatening life and property. Last summer, there was a proliferation of fires. From June 26, 2020 through July 6, 2020, the Tacoma Fire Department (TFD) responded to 122 fires. Of these, 32 were fireworks-related (or 26%)

and resulted in damage of over \$480,000. During the same reporting period, TFD treated six fireworks-related patients. In 2019, in South King County, fireworks led to the death of a man in his 70s and a dog, along with the destruction of two homes by fire and displacement of 12 residents.¹ The 2017 Eagle Creek Fire in Oregon burned 48,000 acres, crossing stateliness, cost approximately \$25 million to contain, and was the result of a teenager setting off fireworks.² This summer is anticipated to be hot and dry – perfect weather for fires.

Personal use of fireworks has been illegal in the City of Tacoma since 1992.³ The sale, transportation, discharge, storage, or use of fireworks within the City is prohibited,



except for display fireworks discharged by a professional at a permitted event. This ban applies each day of the year.⁴ Illegal use of fireworks is classified as a Class 2 civil infraction. The maximum penalty amount is \$125, and with assessments, totals \$257 to the person being cited. State law establishes the maximum penalty amounts, excluding assessments.⁵ This has done little to deter the illegal use of fireworks in Tacoma and nation-wide during the 2020 July 4th holiday.⁶ Fireworks can be heard citywide year round, and becomes more prevalent the closer July 4th gets, upsetting sleeping infants, military veterans, rescue dogs, and others. Unlawful use of fireworks are a serious fire hazard and dangerous to the community.



Increasing the penalty on the illegal use of fireworks from a Class 2 civil infraction to a Class 1 civil infraction would increase the maximum fine to \$250, and with assessments, the total fine would be \$513. An increase in the fine would serve as a deterrent to those individuals thinking about using fireworks in city limits. Understanding that fireworks is one of the most difficult offenses to enforce, the expectation is not that the Tacoma Police Department would be able to increase enforcement, but that strengthening the deterrent may resonate with residents who consider using fireworks in the city.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

Residents who engage in the unlawful, personal use of fireworks in the City of Tacoma, residents in the vicinity of those who engage in the unlawful use of fireworks, the Tacoma Police Department, and the Tacoma Fire Department will all be impacted. Community members in the South End have expressed concern for several years about the unlawful use of fireworks in the neighborhood, especially around Alling Park. The situation has not improved and residents are eager to see these dangerous activities reduced.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility: (Mandatory)

This legislation will reduce inequities by increasing public safety through the use of a stronger deterrent to reduce the number of people engaging in unlawful use of fireworks, especially prevalent in areas of "low" or "very low" opportunity based on the City's Equity Index.

Livability: Equity Index Score: Moderate Opportunity

Increase positive public perception of safety and overall quality of life.

Increasing the penalty on illegal use of fireworks will serve as a deterrent to individuals considering using fireworks in the City of Tacoma and reduce these unlawful incidents. EVALUATION AND FOLLOW UP:

The Tacoma Fire Department tracks data on fireworks-related fires, responses, and EMS patients. Success will look like a reduction of these incidents in the coming years. The Tacoma Fire Department, in collaboration with the Tacoma Police Department, are requested to present to City Council Study Session one year from passage of this legislation on the number of fireworks-related incidents that were responded to in the previous year and any recommendations on how to achieve a reduction in the use of illegal fireworks.

STAFF/SPONSOR RECOMMENDATION:

The recommendation is to pass this ordinance to reclassify the illegal use of fireworks from a Class 2 civil infraction to a Class 1 civil infraction, effective immediately, to promote public safety through strengthening the legal deterrent.
