

- Limited Fossil Fuel Facility Expansion
- Fossil Fuel Facility Maintenance, Safety, Security, Required Regulatory Modifications
- National Security Fossil Fuel Facilities
- Marine Vessels Fossil Fuel Facilities
- Projects which have undergone Environmental Review and Mitigated Impacts
- New and Expanded Renewable Facilities Outright Permitted
- Prohibition of any Fossil Fuel facility Expansions or modifications
- Limit throughput of New or Existing Fossil Fuel Facilities
