#### **4. 21-0364**

Six-Year Comprehensive Transportation Improvement Program [Jennifer Kammerzell, Principal Engineer, Public Works]

At approximately 4:31 p.m., Jennifer Kammerzell, Principal Engineer, Public Works (PW), presented the Six-Year Comprehensive Transportation Improvement Program (TIP), including an overview, background, projects to be removed, projects to add, the South 21st and "C" Street traffic signal, South Cedar Street active transportation enhancements, South Tacoma Sounder Station access, and next steps.

Discussion ensued regarding South Sheridan Avenue from 72nd Street to 61st Street.

The Infrastructure, Planning, and Sustainability Committee recessed at 4:46 p.m.

The Infrastructure, Planning, and Sustainability Committee reconvened at 4:49 p.m.

Discussion continued regarding the Safe Routes to School project, the projects to be removed, and reasons behind the removals.

#### **5. 21-0365**

Puyallup Avenue Transit/Complete Street Improvement Project Update [Mark D'Andrea, Project Manager, Public Works]

At approximately 4:56 p.m., Mark D'Andrea, Project Manager, PW, presented the Puyallup Avenue Transit/Complete Street Improvement Project update, including an overview.

Council Member Walker arrived here, at 5:00 p.m.

Mr. D'Andrea continued with project goals; project summary; outreach for 2016-2017; public feedback; stakeholder feedback; proposed conceptual design alternatives 1 through 3; a summary of outreach; hybrid alternative 4, noting similarities to alternatives 1 and 2, and the concept layout; recent stakeholder outreach and feedback; grant status and decision; and next steps.

Discussion ensued regarding project alternatives and potential impacts; stakeholder outreach; freight traffic in the corridor; vehicle use rate on the corridor at various times and locations; outreach to the Tacoma Dome Business District; options for parking, sidewalks, pedestrians, and bicycles along the corridor; and Americans with Disabilities Act compliance with

transit options.

MOTION: Council Member Walker moved to recommend the Public Works' staff recommendation regarding grant acceptance and project funding to the full City Council for consideration.
