## **Call to Order**

Mayor Woodards called the study session to order at 12:03 p.m.

#### **Roll Call**

All Council Members participated virtually.

## **Briefing Items**

1. <u>21-0385</u> Department of Corrections Work Release Site Update

At approximately 12:04 p.m., Mark Kucza, Reentry Senior Administrator and Project Lead, Department of Corrections (DOC), provided opening remarks; introduced Tony Lindgren, Partner, KMB Architects; and presented an update on the DOC work release site, including DOC's mission and vision, meeting objectives, description of the work release program, placement criteria, participant expectations, progression through the program, population demographics and recidivism percentages, a cost-benefit analysis, impacts of the 2007 Engrossed Substitute Senate Bill 6157, existing and proposed distribution of work release beds by county, current facilities, building components, examples of specific facilities, and capacity shortages in several counties. Mr. Lindgren outlined the work release expansion project, including a project history, expectations of the local advisory committee, site selection steps, consideration for expansion of the Tacoma Community Justice Center Annex site located at 1007 Center Street, and a description of the site. Mr. Kucza concluded with review of the project website and resources, project communications, contact for the Pierce County project via email at docwrexpandpc@doc1.wa.gov, and next steps.

Discussion ensued regarding recidivism, training and mentorship opportunities, requirements and consequences, community outreach and public comments, consideration of other locations around Pierce County, detention center regulations, support systems, how a participant's county of origin is determined, previously used sites, length lease agreements, and next steps for site evaluation and updates to the City Council.

#### 2. <u>21-0386</u> 21st Century Policing Solutions Recommendations for the Tacoma Police Department

At approximately 12:51 p.m., Kathleen O'Toole, Partner, 21st Century Policing Solutions (21CP), provided opening remarks and introduced Brian Maxey and Ganesha Martin, Associate Consultants, 21CP. Mr. Maxey presented 21CP's recommendations for the Tacoma Police Department (TPD), including the methodology used; the areas of evaluation; addressing community needs, noting community interest, TPD staff's willingness to listen, and the community safety plan; critical operations, noting use of force, pursuits, bias-free policing, stops, searches, arrests, and crisis intervention; organization and command structure, noting a recommendation to add a Chief of Staff position, expanding civilian leadership, succession planning, and a community policing structure; officer support, wellness, and supervision, noting training, leadership, the Police Training Officer program, early intervention and early warning, officer wellness, and employee assistance; accountability systems, noting complaint review, misconduct systems, complaint systems, and independent oversight; and technology, noting data systems, transparency, and a technology roadmap.

Discussion ensued regarding national events, and a proposal to schedule City Council discussion with 21CP at a future date.

# 4. <u>21-0392</u> Council Consideration Request: Exploring Establishment of a Cultural or Heritage Holiday

Mayor Woodards presented a Council Consideration Request requesting support to explore the establishment of a potential paid cultural or heritage holiday for City of Tacoma staff, noting Washington State's declaration of Juneteenth as a holiday, how other jurisdictions have addressed the issue, requesting feedback from affinity groups, and review by the Government Performance and Finance Committee prior to City Council action.
