SUBJECT: Ordinance - Amend Tacoma Municipal Code Section 12.01.030 - September 14, 2021

SUMMARY AND PURPOSE:

An ordinance amending section 12.01.030 of the Tacoma Municipal Code, relating to utility billing, to conform the code to current practices of providing refunds or credits for amounts paid by utility customers determined by the City to have been overbilled, and authorizing the Tacoma Public Utilities Director and Environmental Services Director to establish policies and procedures governing approval of such refunds and credits.

BACKGROUND:

This Department's recommendation is based on: Tacoma Municipal Code (TMC) sections 12.01.030 A-C establish the billing process for Tacoma's utility services. This process includes provisions in subsection C.3 for wavier or adjustment of utility service charges that are due and owing but were billed in error but does not include a provision allowing refund or credit for amounts paid by the utility customer when determined by the City to have been billed in error. The utilities have had policies and practices in place to provide refunds or credits to customers who were billed in error. The proposed ordinance would conform the TMC to current policies and practices by authorizing the Director of Tacoma Public Utilities and the Director of Environmental Services to provide refunds or credits to utility customers who are determined to have been billed in error, and to establish policies and procedures governing approval of such refunds and credits.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

All utility customers will benefit from the proposed amendment that will clarify the authority to provide a credit or refund for customers who have been overbilled through an error caused by the City.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

Providing clear authority to issue credits and refunds will benefit all ratepayers, but may be particularly important to low income ratepayers because utility bills consume a larger portion of the household budget.
