A RESOLUTION relating to the Department of Public Utilities, Rail Division 1 (d.b.a. "Tacoma Rail"); authorizing the execution of three interest-free loan 2 agreements with the Washington Department of Transportation, in the total amount of \$1,651,000, accepting and depositing said sum into the 3 Tacoma Rail Fund, and further authorizing matching City funds in the amount of \$2,958,931, to partially finance three separate railroad 4 improvement projects. 5 WHEREAS the City of Tacoma, through its Department of Public Utilities, 6 7 Rail Division (d.b.a. "Tacoma Rail"), was awarded interest-free loans through a 8 competitive call for projects initiated by the Washington State Department of 9 Transportation, with subsequent funding appropriated by the State Legislature in 10 the 2021 session, and 11 WHEREAS the loan agreements are for varying amounts, totaling 12 \$1,651,000, as described below: 13 14 1) Agreement No. RRB-1269, Improvements to Locomotive Maintenance 15 and Fueling Facility in the principal amount of \$868,000 less a 3.23 16 percent administrative fee of \$28,000, with ten annual payments of 17 \$86,800 plus Tacoma Rail must provide a minimum match of \$1,826,264 18 19 toward the completion of the project prior to June 30, 2023; the loan will 20 partially finance the upgrade of an existing locomotive fueling and 21 servicing facility, by replicating features on an additional track, increasing 22 the fuel storage capacity in support of two value added service contracts, 23 and associated work to enhance operational efficiencies and systems 24 25 resilience; 26

1		principal amount of \$318,000 less a 2.52 percent administrative fee of
2		\$8,000, with ten payments of \$31,800 plus Tacoma Rail must provide a
3 4		minimum match of \$369,471 toward completion of the project prior to
5		June 30, 2023; to partially finance the upgrade of approximately 600
6		lineal feet of railroad track, including the replacement of two track turn-
7		outs, and the removal and replacement of three private crossings; and
8	3)	Agreement No. RRB-1276, Tacoma Rail Yard Tracks Upgrade Project, in
9		a principal amount of \$465,000 less a 3.23 percent administrative fee of
10 11		\$15,000 with ten annual payments of \$46,500 plus Tacoma Rail must
12		provide a minimum match of \$763,196 towards the completion of the
13		project prior to June 30, 2023; to partially finance the upgrade of
14		approximately 2,400 lineal feet of railroad track, including three track turn-
15		
16	outs, in Tacoma Rail's main rail yard, and	
17	WHEREAS Tacoma Rail's freight infrastructure in the Tideflats area is	
18	heavily used and in need of periodic upgrades in order to facilitate the switching of	
19 20	railcars destined for customers in the Port of Tacoma and other outlying areas, and	
20 21	WHEREAS under Article IV, Section 4.11 of the Tacoma City Charter, all	
22	matters relating to incurring of indebtedness are initiated by the Board subject to	
23	approval by the City Council, and	
24	WHEREAS, by adoption of Public Utility Board Resolution No. U-11280 on	
25	September 8, 2021, the proposed Agreements were approved, pending	
26	confirmation from the City Council, and; Now, Therefore,
