Tacoma Power and Water Financial Plans Review
[Bill Berry, Rates, Planning, and Analysis Manager; Jodi Collins,
Assistant Water Division Manager, Tacoma Public Utilities]

At approximately 10:01 a.m., Bill Berry, Rates, Planning, and Analysis Manager, Tacoma Public Utilities (TPU), presented Tacoma Power's financing plan, including background; the time frame for issuing bonds to pay down the drawdown facility loan; and a new short-term financing agreement, noting an overview, benefits and planned activities. Mr. Berry concluded by outlining the proposed schedule of the process. Jodi Collins, Assistant Water Division Manager, TPU, presented Tacoma Water's financing plan, including background, noting the capital expense budget and forecast and the Capital Funding Plan for 2021-2022; and debt refinancing opportunities, noting existing debt service on the 2013 Water System bonds and 2013 Regional Water Supply System bonds, taxable advance refunding, and tax-exempt advance refunding.

Discussion ensued throughout regarding Tacoma Power's short-term financing facility and its cost effectiveness, Tacoma Power's Long-Range Financial Plan, and the number of financial institutions that submitted proposals for Tacoma Power's new short-term financing agreement.
