ITEMS OF INTEREST

- 1. City Manager Elizabeth Pauli provides the attached **Purchase Contract Awards** for the week of September 27, 2021.

- 3. Interim Police Chief Ake provides the attached **Weekly Crime Report** for the weeks of September 13-19 and 20-26, 2021.
- 4. <u>City-funded Temporary and Emergency Shelter Performance</u>: The City posts weekly information about its Temporary and Emergency Shelter locations including current census, number of available beds and exits to housing. **This information can be found at** https://cms.cityoftacoma.org/NCS/City%20Authorized%20Emergency%20Shelter%20Sites/Weeklydataupdate.pdf and is updated weekly.

The City is also developing an additional 185 shelter units, many of which will be activated over the next several weeks, with the Comfort Inn project expected to be operational by the end of the year.

- 20 units at S. 69th and Proctor
- 25 units at 82nd and Pacific
- 80-100 units at the Comfort Inn
- 5. <u>Senior Meal Delivery</u>: Access to healthy meals is important to our senior population and the City has adjusted contracted services during the COVID-19 pandemic to ensure seniors can still access food while senior centers are not operating. The City's contracted partner ensured pickup and delivery of **395 meals for the week of September 20-24, 2021**.
- 6. <u>Temporary Shelter at Shiloh Baptist Now Operating</u>: A temporary shelter location at Shiloh Baptist Church located at 1211 S. I Street began operating on Monday, September 27th. **The shelter will serve single men and has capacity to serve 40 individuals**. Referrals are made from the Homeless Outreach Team and overflow from Tacoma Rescue Mission and Catholic Community Services' overnight shelters. This shelter location operates 24/7 and is funded to operate through March 2022.

- 7. Temporary Isolation and Quarantine Site: Tacoma-Pierce County Health Department has opened the temporary isolation and quarantine site at The Lighthouse Senior Center at 5016 A Street. This location provides a place for people who test positive for COVID-19 and need a safe place to isolate. Please see the attached Health Department flier for additional information.
 - We expect the site will operate through Oct. 31, 2021
 - The site will operate 24 hours a day, 7 days a week.
 - The site will have 10 beds.
 - The site will provide shelter for adults 18 years or older.
 - An average stay will last 10-14 days.
- 8. Rental Assistance: The rental assistance portal is open! Residents may find more information at https://www.piercecountywa.gov/7142/Rental-Assistance. The program provides up to 12 months of assistance dating back to March 2020 and serves households up to 80% of Pierce County Area Median Income. Applicants may also qualify for utility assistance through the program. The City remains committed to reducing racial disparities in our service delivery and for this reason has a goal of providing at least 45% of the assistance to households headed by persons of color. In 2020, 638 households received assistance from the Tacoma Rental Assistance Program. Of those 638, 78% were households with the head of household identifying as a person of color. In 2021, 62% of households served to date are headed by persons of color.

In 2021, the City has provided 464 households with \$3,365,980 in rental assistance (this is an increase of 15 households and \$85,879 in assistance over last report) and 1,021 households with \$1,234,500 with utility assistance (this is an increase of 119 households and \$159,391 in assistance over last report). This emergency rental and utility assistance is available from the U.S. Department of Treasury for expenditure through September 30, 2022. The City's Rental Assistance Fund at the Greater Tacoma Community Foundation has received 28 gifts totaling \$30,820.

SUBJECT: 2021 Wastewater CIPP Sewer Rehabilitation Project in Various Tacoma

Locations - Request for Bids Specification No. ES21-0017F

DATE: September 15, 2021

Pursuant to the City of Tacoma March 12, 2020, state of emergency proclamation in response to COVID-19, made in accordance with Tacoma Municipal Code Chapter 1.10., contract awards for purchases must be approved by the City Manager or designee.

RECOMMENDATION SUMMARY:

The Environmental Services Department recommends a contract be awarded to Insituform Technologies LLC, Chesterfield, MO., in the amount of \$985,141.00, plus a ten percent contingency, for a cumulative contract total of \$1,083,655.10, plus applicable taxes, budgeted from the ES Wastewater Fund 4300, for the rehabilitation of approximately 2.4 miles of underground wastewater pipes in various locations throughout the city.

STRATEGIC POLICY PRIORITY:

- Strengthen and support a safe city with healthy residents.
- Assure outstanding stewardship of the natural and built environment.

A reduced risk of wastewater overflows represents an improvement to human health and environment. For this construction work, the City is able to utilize cured-in-place pipe (CIPP) trenchless technology to rehabilitate these existing wastewater pipes without undertaking the more expensive and disruptive impact of traditional open-cut construction.

BACKGROUND:

Rehabilitation of these pipes will reduce the risk of future failures. Pipe failures can result in overflow of untreated wastewater into the Puget Sound or private property. This work will rehabilitate approximately 12,800 linear feet of 8-inch to 24-inch diameter underground pipe utilizing CIPP trenchless technology. Preventative maintenance of these underground pipes in these project areas represents the lowest life cycle cost solution to maintaining these assets.

ISSUE: The underground wastewater pipes in these various locations are reaching the end of their design life and are at risk of failure.

ALTERNATIVES: One alternative is taking no action and accepting the risk of continued pipe failures, which can result in untreated wastewater overflowing into the Puget Sound or private property. An alternative construction method, traditional open-cut trenching, would result in higher costs and a more significant impact to the neighborhoods during construction.

COMPETITIVE SOLICITATION:

Request for Bids Specification No. ES21-0017F was opened August 31, 2021. Two companies were invited to bid in addition to normal advertising of the project. Two submittals were received.

Insituform Technologies LLC submitted a bid that resulted in the lowest evaluated submittal after consideration of EIC participation requirements. The table below reflects the amount of the base award.

Pre-bid Estimate: \$930,002.50

The recommended award is 5.9 percent above the pre-bid estimate.

CONTRACT HISTORY: New contract.

SUSTAINABILITY: Replacement of these pipes will reduce the risk of failure, thereby reducing the potential for discharge of untreated wastewater into the Puget Sound, resulting in a positive environmental impact.

EIC/LEAP COMPLIANCE: The recommended contractor is in compliance with the Equity in Contracting (EIC) Regulation requirements per memorandum dated September 9, 2021. The EIC requirements for this project are four percent for Minority Business Enterprise (MBE), two percent for Women's Business Enterprise (WBE), and six percent for Small Business Enterprise (SBE). The EIC utilization levels of the recommended contractor, Insituform Technologies LLC are seven percent MBE, seven percent WBE, and seven percent SBE. Local Employment Goal of fifteen percent and Apprentice Utilization Goal of fifteen percent.

DATE: September 29, 2021

On August 30, 2021, the Infrastructure, Planning and Sustainability (IPS) Committee completed its review of the Planning Commission's proposed Tideflats and Industrial Land Use Amendments, and forwarded recommended modifications for City Council consideration. The IPS Committee recommendations are available online at www.cityoftacoma.org/tideflatsinterim.. A public hearing is scheduled for October 5, 2021 on the IPS Committee recommendations.

At the October 5, 2021 City Council study session, staff will present an overview of the IPS Committee process and recommendations to prepare for the City Council public hearing that evening.

BACKGROUND:

On October 20, 2020, the City Council passed Amended Ordinance No. 28696, which extended the Tideflats interim regulations an additional six months and also directed the Planning Commission and staff to begin a process to develop new recommendations for a non-interim ordinance to replace the interim regulations ahead of the completion of the subarea plan.

On April 7, 2021, the Planning Commission forwarded its Findings of Fact and Recommendations report to the City Council for review and consideration.

On April 27, 2021, the City Council conducted a public hearing on the Planning Commission's Findings of Fact and Recommendations. In support of the public hearing, approximately 40,000 public notices were provided to potentially affected taxpayers, occupants, and interested parties, and email notices were provided to over 500 other interested parties. The City Council received over 400 pages of public comments.

On May 18, 2021, the City Council passed Ordinance No. 28759, approving an extension of the Tideflats interim regulations for up to six months, and referring proposed permanent regulations to the IPS Committee for review and recommendation to the full City Council no later than August 31, 2021.

On August 30, 2021, the IPS Committee concluded its review and recommendations and forwarded those proposals to the City Council. The proposed IPS amendments are available at www.cityoftacoma.org/tideflatsinterim.
