SUMMARY AND PURPOSE:

A resolution confirming the dissolution of the Foss Waterway Development Authority ("FWDA") on December 31, 2020, providing documentation for those outside entities and organizations requiring such confirmation for ongoing City of Tacoma activities and actions necessary to the Foss Waterway management.

BACKGROUND:

The FWDA's final operating agreement expired on December 31, 2020. Based on a Transition Agreement executed between the FWDA Board and City Manager, all properties, leases, operating obligations and assets of the FWDA were transferred to the City by said date. In continuing to manage activities of the waterway, such as property leases and sales, agreements with the Department of Natural Resources and banking accounts, as well as other routine obligations, some outside agencies and entities have requested additional confirmation of the City's authority and ownership in addition to the Operating Agreement expiration and Transition Agreement. This Resolution provides the official confirmation requested by outside agencies and entities.
