RESOLUTION NO. 40853

1 A RESOLUTION relating to economic development; confirming the dissolution of the Foss Waterway Development Authority on December 31, 2020, providing 2 documentation for those outside entities and organizations requiring such confirmation for ongoing City of Tacoma activities and actions necessary to 3 the Foss Waterway management. 4 WHEREAS, the Foss Waterway Development Authority ("FWDA") was 5 created by the City in 1996 to assist in redeveloping certain real property along the 6 7 Thea Foss Waterway, and 8 WHEREAS to accomplish this purpose, the City and FWDA entered into a 9 series of Operating Agreements, the last of which expired December 31, 2020, and 10 WHEREAS, the final Operating Agreement provided at Section 2.1 that prior 11 to the expiration of that Operating Agreement, the City and the FWDA would 12 13 develop either a new Operation Agreement or agree to a transition process 14 concluding with orderly dissolution of the FWDA and transfer of its assets including 15 real property, obligations and contractual agreements to the City, and 16 WHEREAS, as the FWDA was not envisioned to be a permanent entity, and 17 by 2020 had completed the majority of development work and set the stage for the 18 19 small remainder of sites, the City and FWDA agreed to the dissolution of the entity 20 and the orderly transition was memorialized in the 2020 Transition Agreement 21 between the FWDA and the City which was approved by Resolution of the FWDA 22 Board, and 23 24 25 26 -1-
