## **ITEMS OF INTEREST**

- 1. The City Manager's Office provides the attached approved **Purchase Contract Awards** for the week of October 11, 2021.

- 4. <u>City-funded Temporary and Emergency Shelter Performance</u>: The City posts weekly information about its Temporary and Emergency Shelter locations including current census, number of available beds and exits to housing. **This information can be found at** <a href="https://cms.cityoftacoma.org/NCS/City%20Authorized%20Emergency%20Shelter%20Sites/Weeklydataupdate.pdf">https://cms.cityoftacoma.org/NCS/City%20Authorized%20Emergency%20Shelter%20Sites/Weeklydataupdate.pdf</a> and is updated weekly.

The 20 additional units at S. 69th and Proctor recently came online, and the Homeless Outreach Team and other service providers are working to get individuals connected to these locations. The City is also working to bring on several additional shelter units that are expected to be available by the end of the year.

- 25 units at 82<sup>nd</sup> and Pacific
- 80-100 units at the Comfort Inn
- 5. <u>Senior Meal Delivery</u>: Access to healthy meals is important to our senior population and the City has adjusted contracted services during the COVID-19 pandemic to ensure seniors can still access food while senior centers are not operating. The City's contracted partner ensured pickup and delivery of **246 meals for the week of October 4- 8, 2021.**
- 6. Rapid Graffiti Removal: On Thursday, October 7, 2021, the City mailed over 24,500 postcards to private property owners in Tacoma with information about the Rapid Graffiti Removal Program and how to enroll into the program to receive services up to three times a year at no cost to the property owner. The postcards were targeted at areas of low/very low opportunity, according to the Equity Index, and where there are high rates of open code cases for graffiti and low programmatic participation or areas that are highly trafficked. The City has already received robust response to the mailing and is in process to address 13 new properties with graffiti removal needs.

7. <u>Isolation and Quarantine at Lighthouse Activity Center</u>: The City has worked with the Tacoma Pierce County Health Department to extend use of the Lighthouse Activity Center as an isolation and quarantine (I&Q) location through Tuesday, November 30, 2021. This effort will continue to support the community's need for a low barrier location to safely isolate and quarantine individuals testing positive for COVID-19.

The I&Q Center has served 10 individuals with an average stay of 10-14 days. TPCHD provides transportation to and from the site, face masks, meals, hygiene kits, beds, and connections to supportive services. Senior meal preparation and distribution being provided at Lighthouse have been temporarily moved to the Beacon Activity Center and continue to operate.

8. Rental Assistance: The rental assistance portal is open! Residents may find more information at <a href="https://www.piercecountywa.gov/7142/Rental-Assistance">https://www.piercecountywa.gov/7142/Rental-Assistance</a>. The program provides up to 12 months of assistance dating back to March 2020 and serves households up to 80% of Pierce County Area Median Income. Applicants may also qualify for utility assistance through the program. The City remains committed to reducing racial disparities in our service delivery and for this reason has a goal of providing at least 45% of the assistance to households headed by persons of color. In 2020, 638 households received assistance from the Tacoma Rental Assistance Program. Of those 638, 78% were households with the head of household identifying as a person of color. In 2021, 62% of households served to date are headed by persons of color.

In 2021, the City has provided 513 households with \$3,596,330 in rental assistance (this is an increase of 28 households and \$148,901 in assistance over last report) and 1,155 households with \$1,391,179 with utility assistance (this is an increase of 74 households and \$76,187 in assistance over last report). The City's Rental Assistance Fund at the Greater Tacoma Community Foundation has received 28 gifts totaling \$30,820.

Pursuant to the City of Tacoma March 12, 2020, state of emergency proclamation in response to COVID-19, made in accordance with Tacoma Municipal Code Chapter 1.10., contract awards for purchases must be approved by the City Manager or designee.

#### **RECOMMENDATION SUMMARY:**

The City of Tacoma Information Technology (IT) Department requests an increase to contract number 4600014301 with Morris Willner and Partners Inc., Santa Ana, CA, in the amount of \$1,000,000, plus applicable taxes, budgeted from the Information Services Fund, for the contract term of May 6, 2020 through May 6, 2022, for a projected cumulative contract amount of \$1,950,000, for professional services and temporary staffing.

## STRATEGIC POLICY PRIORITY:

Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

### **BACKGROUND:**

In 2020, the Information Technology Department established a master contract for temporary staffing services that was awarded to eight different companies. The total contract amount of \$7,000,000 had to be distributed among the eight companies. Not knowing which company's services would be used at which volume, the IT Department assigned the eight different companies various amounts based on their contract history with the City. Morris Willner and Partners, Inc. were assigned \$950,000. Those funds have been allocated through various projects. Additional funds need to be added to their contract allocation in order to contract further with Morris Willner and Partners, Inc.

ISSUE: The demand for experienced technology personnel exceeds the capacity of City staff.

ALTERNATIVES: Morris Willner and Partners, Inc. is a trusted resource for the City. They provide high value resources in hard to fill roles. Without these additional funds, the City would not be able to continue to contract with Morris Willner and Partners, Inc. An alternative to adding funds to the contract would be to amend a contract from one or more of the other vendors on the Master Services Contract, reducing the amount allocated to them and increasing the amount allocated to Morris Willner and Partners, Inc. This shift of allocated funds would not impact the total contract amount of \$7,000,000, but it would likely cause confusion



among the other vendors that are impacted and may lead to less participation in the master services request process. Additionally, instead of only amending one contract to add funds, Purchasing and the IT Department would have to amend multiple contracts to re-allocate the funds.

#### **COMPETITIVE SOLICITATION:**

Request for Proposals Specification No. IT19-0441F was opened December 24, 2019. Twenty-six companies were invited to bid in addition to normal advertising of the project. Thirty-two submittals were received.

The below vendors submitted a bid that resulted in the highest evaluated submittal after consideration of SBE participation goals. The table below reflects the amount of the base award.

Pre-bid Estimate: \$7,000,000

The recommended award was zero percent above the pre-bid estimate. This amendment request will increase the total awarded to 14.2 percent above the Pre-bid Estimate. However, the allocated funds will only be spent if the temporary staffing services is requested. These allocations are not guaranteed to any vendor.

CONTRACT HISTORY: This contract was originally awarded to Morris Willner and Partners, Inc. as a result of Request for Proposals Specification No. IT19-0441F in April 2020. This is the first amendment to increase the contract allocation. This is a three-year contract with the option for two one-year renewals.

SUSTAINABILITY: Vendors were evaluated on their company's commitment to the environment to include their sustainability practices.

**DATE:** September 20, 2021

Pursuant to the City of Tacoma March 12, 2020, state of emergency proclamation in response to COVID-19, made in accordance with Tacoma Municipal Code Chapter 1.10., contract awards for purchases must be approved by the City Manager or delegee.

#### **RECOMMENDATION SUMMARY:**

The Finance and Retirement Departments recommend a contract be awarded to Ceridian, Minneapolis, MN, in the amount of \$424,811 for implementation and an annual recurring fee of \$699,650 along with \$76,939 in contingency funds, plus applicable taxes, for an initial contract term of three years with option to renew for two, one-year terms, for a projected contract amount of \$4,000,000, to process City of Tacoma's payroll and pension payments.

### STRATEGIC POLICY PRIORITY:

• Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

#### **BACKGROUND:**

Currently, the City's payroll is processed through SAP. It is processed bi-weekly and the Tacoma Employees' Retirement System and Police and Fire Pensions are processed monthly. This requires the intervention of City staff, especially toward the end of each year when the City is required to update SAP with the latest tax forms and information. The internal labor cost of performing the annual SAP update is close to \$500,000 with the actual cost being much higher due to required coordination and projects having to be put on hold. In 2027, SAP will no longer support the payroll module.

On December 3, 2020, Finance received approval from the Business Process Owners Committee (BPOC) to move forward with the transition from in-house payroll to a managed service. A Request for Proposals (RFP) was issued on February 12, 2021 and after vendors' interviews, presentations, and demonstrations, Ceridian was selected on June 7, 2021.



#### ISSUE:

The SAP system will reach end of life in 2027 and the City will be forced to find another payroll solution to enable us to continue to pay the roughly 6,400 City employees, pensioners, and non-City-of-Tacoma members. The managed payroll service will replace the payroll module in the City's current enterprise software platform (SAP) and provide a portal to all pensioners to be able to access forms and update basic information, such as address and beneficiaries, much like our current Employee Self Service portal.

Each year, the City is required to update SAP with the latest tax forms and information to adequately pay employees and pensioners. The effort takes almost three months towards the end of each year and has been very costly, as well as disruptive to in-flight projects, as it requires projects to be paused, even if there are many contractors on board. Moving to a managed payroll service provider, the City will no longer need to update SAP each year and will have the ability to plan updates around projects.

Since payroll is the only SAP module that requires the annual support packs, the move to a managed payroll service will allow the City to continue running SAP beyond 2027.

### **ALTERNATIVES:**

Two other alternatives were evaluated during the business case development: Business as Usual and Full Human Capital Management (HCM) Implementation.

For Business as Usual, Payroll and Retirement could continue with SAP, the result may include incorrect tax calculations, lack of support/updates, fines, inability to process personnel data, additional work-around for new reporting requirements, and slow data retrieval. The manual processes would also increase, requiring increased labor from payroll and IT staff and decreasing efficiency. This option was deemed as too risky for the City.

For Full HCM Implementation, this option would include replacing the entire HCM module (e.g., Organizational Management, Time Management, Benefits). It is not viable at this time due to budget constraints and the significant impact it would have to the whole organization (i.e. retraining all employees and pensioners, timekeepers, data administrators, managers, etc.).

The recommended alternative, Managed Payroll Service, would allow Payroll and Retirement staff to operate more efficiently and effectively. Having a payroll and retirement managed service would allow for ease of configuration to meet new state/federal and local programs, while using less in-house resources. It would provide the City the flexibility to hire out-of-state employees, provide employees/pensioners a self-service portal, ability to calculate an employee's final pay-out on their last day, minimize payroll tax reporting administration, and handle rules of the collective bargaining agreements, therefore, allowing staff to focus on other projects.

### **COMPETITIVE SOLICITATION:**

Request for Proposals Specification No. FI21-0032F was opened February 12, 2021. Six companies were invited to bid in addition to normal advertising of the project. Four submittals were received. Two submittals were deemed non-responsive based upon not meeting minimum

requirements. Both of the remaining vendors were interviewed with the suggested awardee scoring highest prior to and following these meetings.

Pre-bid Estimate: \$403,000 for implementation and \$700,000 for recurring costs. The recommended award is 5.4 percent more than the pre-bid estimate for implementation costs and 1 percent less for annual recurring charges.

**CONTRACT HISTORY: New contract** 

SUSTAINABILITY: Ceridian will perform duties and responsibilities of the contract remotely, reducing the environmental impact of travel. Providing pensioners access to a portal to view information and forms as well as update basic information will reduce paper documents. The scoring criteria included five point for considerations of company's sustainability efforts.

EIC/LEAP COMPLIANCE: The scoring criteria included five points for EIC considerations.



## **ALT. #2**

#### MOTION: 1. New and Expanded Cleaner Fuel Facilities Conditionally Permitted

I move to allow through a conditional use permit process, including enhanced SEPA review where applicable, infrastructure for the production, storage, transportation and transshipment of fuels that are carbon-free and generate no carbon emissions including green hydrogen and other carbon-free fuels produced with renewable electricity such as hydroelectric power, and fuels that are approved by the US Environmental Protection Agency under the federal Renewable Fuel Standard program, or under Washington State Law, including credit generating fuels under the Clean Fuel Standard (CFS) program, this includes infrastructure for:

- a. Any credit generating fuel under the Washington CFS that can be demonstrated to be credit generating through the life of the CFS, or 2035, whichever is longer.
- b. Any EPA approved and listed fuel under the RFS, if such fuel is also credit generating under the WA state CFS.
- c. Credit generating Renewable diesel, as described in subsection (a.) above, meeting Washington State requirements under the CFS.
  - d. Green hydrogen, or electricity, produced or stored for use as fuels in a motor vehicle that meet California motor vehicle emission standards as described in Washington State law.

#### **MOTION 1. DRAFT CODE**

### **Definitions**

"Cleaner Fuels" shall mean carbon-free fuels that generate no carbon emissions including hydrogen, any credit generating fuel under the life of the Washington Clean Fuel Standard, or 2035, whichever is longer, any credit generating blends of EPA approved and listed fuel under the federal Renewable Fuel Standard so long as they are credit generating under the WA CFS for the life of the standard, or 2035, whichever is longer, any Renewable Diesel meeting the requirements of Washington State law so long as they are credit generating under the WA CFS for the life of the standard, or 2035, whichever is longer, any hydrogen, or electricity, produced or stored for use as fuels in a motor vehicle that meeting the motor vehicle emission standards for Alternative Fuels in Washington State law.

"Dirty Fuel" shall mean any fuels not meeting the Cleaner Fuels definition.

"Enhanced SEPA Review" shall mean additions to the standard SEPA review process and checklist for project proposals governed by this chapter to be promulgated and updated from time by the Director. Such additions to the SEPA review process and checklist shall include but not be limited to; a public meeting for a SEPA application, which occurs after SEPA determination that an application is complete but prior to issuance of a preliminary threshold determination; an expanded Notice Distribution List to include direct mailing to taxpayers and occupants, consistent with Land Use Permits; expanded Public Notification Distance for Direct Mailing to 2500' from the Manufacturing and Industrial

Center, consistent with Land Use Permits; expanded Notification Period and Comment Period for SEPA to 30 days for Consistency with Land Use Permits, and a supplemental checklist specific to SEPA review of fuel production and or chemical manufacturing.

"Expanded Cleaner Fuel Infrastructure" shall mean the expansion of storage infrastructure including tankage constructed prior to effective date of this chapter to store credit generating fuels under the WA state CFS, where the expansion of such storage infrastructure is for the sole purpose of blending petroleum with biomass and other cleaner fuels in the production of cleaner fuels to meet the credit generating CFS standard through 2035 or the life of the standard, whichever is longer .

"New Cleaner Fuel Infrastructure" shall mean new infrastructure for the production, storage, transportation and transshipment of Cleaner Fuels as defined herein.. New Cleaner Fuel Infrastructure shall not include new tankage for petroleum storage.

"Dirty Petroleum" shall mean crude oil, petroleum products and byproducts, and gaseous hydrocarbons and byproducts, and any other fuel not meeting the definition of Cleaner Fuels as defined herein.

"Storage Capacity" shall be defined as gallons of petroleum capable of being stored within the entirety of the applicant's facility for purposes of measuring expansion as allowed herein.

#### Code

New and Expanded Cleaner Fuel Infrastructure as defined in this chapter shall be allowed through the conditional use permit process, subject to an enhanced SEPA checklist to be implemented and updated from time to time by the Director, and subject to the following requirements.

- 1. All petroleum and related fuel facilities and activities, as well as any fuel facility and activity related to fuels that are projected to become deficit fuels under the WA State CFS standard are declared non-conforming and subject to TMC XX.XX (non conforming use chapter section). Such uses are not allowed to expand capacity under this code.
- Any New or Expanded Cleaner Fuel Infrastructure permitted through this chapter shall not be repurposed for production, storage, transportation and transshipment of petroleum.
   Total or partial conversion of permitted Cleaner Fuel Infrastructure shall constitute grounds for permit revocation and civil enforcement.
- 3. Any Expanded Cleaner Fuel Infrastructure permitted through this chapter shall not exceed a cumulative total increase of fifteen percent (15%) more storage over the applicant's total petroleum storage on the effective date of this chapter. Facilities permitted under this section shall provide independently verifiable data demonstrating the average through put volume of traditional petroleum fuels on site from the previous five (5) years and shall provide a concurrent 15% reduction in volume through put of dirty petroleum from the facility.
- 4. All projects expanding under this chapter shall be subject to a climate impact analysis to ensure documentation of carbon impacts of the project for full offset. Each project shall fully offset lifecycle carbon and GHG emissions of the project impacts through measures such as,

but not limited to, a carbon reduction credits program, physical improvements that reduce carbon emissions, local renewable energy projects, reducing emissions from buildings and transportation networks in the city, a fee in lieu program to local agencies where the in lieu fee program would construct projects meant to reduce carbon emission in the city, consistent with the city's climate action plan.
