Briefing Items

3. <u>21-0556</u> Briefing on Establishing a 5G Innovation Lab for the Tacoma Tideflats [Pat Beard, Business Development Manager, Community and Economic Development]

At approximately 10:08 a.m., Pat Beard, Business Development Manager, Community and Economic Development, gave an overview on establishing a 5G innovation lab for the Tacoma Tideflats, and introduced Joshua Berger, Executive Director, Washington Maritime Blue. Mr. Berger introduced Nathan Tolbert, Director, Tacoma Maritime Innovation Incubator; and Jim Brisimitzis, Founder, 5G Open Innovation Lab. Mr. Berger, Mr. Tolbert, and Mr. Brisimitzis further reviewed Washington Maritime Blue, noting a Strategic Alliance for Maritime Innovation and Sustainability, and an update; background; 5G overview; 5G open innovation lab; innovation opportunities; reasons to locate a 5G innovation lab in the Tideflats; and next steps.

Discussion ensued regarding making Tacoma the only place businesses want to go, other ports, sustainability, cost of a 5G "super" computer, a project built in Snohomish County, where data is currently stored, if demand is foreseen, what types of industries would use the network, if potential customers of the network have been consulted, better communicating how technological investments help the Port, communicating which companies are involved, required resources, difference between this 5G and cell phone 5G, service range, and the United States Department of Defense usage.
