***BACKGROUND



- Pandemic restrictions interrupted in-person outreach
 - Event tabling, focus groups, trainings
- · Leveraged additional grant funding to expand recycling education
 - \$60,000 Ecology grant:
 - · Recycle Ambassador program
 - · Online waste sorting game
 - \$250,000 Recycling Partnership Grant:
 - Materials and engagement for multi-family recycling education
 - \$175,000 US Conference of Mayors grant:
 - · Expand Recycle Ambassador program to multi-family
 - · Add food waste reduction education to Ambassador program

···· Recycle Reset Ambassador Program

- Program leads with equity
- Leverages word of mouth as an amplification strategy.
- Active community residents trained to become Recycle Reset Ambassadors
- In partnership with community organizations: Asia Pacific Cultural Center, Pierce Conservation District, VT Radio Universal, and Safe Streets
- Eight multilingual, multicultural trainings with over 100 participants to date
- Replicable, interactive multilingual curriculum and educational tools

- Identify a South End glass drop-off location 2021-22
