## **RESOLUTION NO. 40864**

1 A RESOLUTION related to collective bargaining; authorizing the execution of a five-year Collective Bargaining Agreement between the City and District 2 Lodge #160, on behalf of Local Lodge #297 of the International Association of Machinists and Aerospace Workers, Track Workers Unit, consisting 3 of eight budgeted full-time equivalent positions, effective retroactive to January 1, 2021, through December 31, 2025. 4 5 WHEREAS the City has, for years, adopted the policy of collective 6 bargaining between the various labor organizations representing employees and 7 the administration, and 8 WHEREAS this resolution allows for the execution of a five-year Collective 9 10 Bargaining Agreement ("CBA") between the City and District Lodge #160, on behalf 11 of Local Lodge #297 of the International Association of Machinists and Aerospace 12 Workers, Track Workers Unit ("Union"), on behalf of employees represented by said 13 Union, and 14 WHEREAS the bargaining unit consists of approximately eight budgeted. 15 16 full-time equivalent ("FTE") positions assigned to Tacoma Public Utilities, and 17 WHEREAS the CBA will provide for a wage increase of 2 percent retroactive 18 to January 1, 2021, and, effective in the first pay period after Council ratification of 19 the agreement, the classification of Railway Track Maintenance Worker will receive 20 an additional 13.5 percent market based adjustment; and the classifications of 21 22 Railway Track Inspector, Railway Track Maintenance Supervisor, and Railway 23 Track Equipment Mechanic-Welder will be re-aligned to 10 percent above the 24 25 26 -1-



Railway Track Maintenance Worker classification; and effective January 1 of each 1 of the calendar years of 2022, 2023, 2024, and 2025, a general wage increase of 2 2 percent will be applied, and 3 WHEREAS other changes include: (1) an update to Article 12 - Non-4 Discrimination; modifying language to provide that the amount paid for meal 5 6 allowances will be prescribed by Section 6.16 of the Tacoma Joint Labor 7 Agreement; (2) changes to language related to scheduling of shift assignments; and 8 (3) other housekeeping updates to reflect gender neutral language, and 9 WHEREAS the CBA was considered and approved by the Public Utility 10 Board at its special meeting of October 27, 2021, and 11 12 WHEREAS it appears in the best interests of the City that the CBA 13 negotiated by said Union and the City be approved; Now, Therefore, 14 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA: 15 That the proper officers of the City are hereby authorized to execute the 16 five-year Collective Bargaining Agreement between the City and District Lodge 17 18 #160, on behalf of Local Lodge #297 of the International Association of Machinists 19 and Aerospace Workers, Track Workers Unit, effective retroactive to 20 21 22 23 24 25 26 -2-
