

# **ORDINANCE NO. 28792**

AN ORDINANCE relating to the Capital Budget; modifying the Capital Budget to recognize changes in transfers, additional revenues, and budget adjustments.

WHEREAS under RCW 35.34, this ordinance is necessary to appropriate estimated expenditures and revenues, and use of available funds for the biennium, and

WHEREAS Exhibit "A" describes the proposed modifications to the Capital Budget, and Exhibit "B" provides a narrative detail about the modifications, and

WHEREAS this amendment is necessary due to variances in capital revenue projections, unforeseen expenditure adjustments and/or needs, and to ensure execution of capital budget commitments; Now, Therefore,
