BRIEFING ITEM

1. 21-0538 Consideration of a Council Statement Regarding the Attorney General's Charging Decision Related to the Death of Manuel Ellis.

At approximately 12:32 p.m., Mayor Woodards presented opening remarks on the proposed joint City Council statement regarding the Washington State Attorney General's Office (AGO) charging decision related to the death of Manuel Ellis. City Manager Elizabeth Pauli outlined the City's disciplinary process, noting that no disciplinary action will take place today.

Discussion ensued regarding expressing condolences to Manuel Ellis' family; recognizing community concerns; the leave and employment status of the officers involved; frustration with the length of the process to date; the charges filed with the Pierce County Superior Court, noting that two officers were charged with manslaughter in the first degree and murder in the second degree while one officer was charged with manslaughter in the first degree, that the AGO will prosecute the cases, and that warrants have been issued; that the case will likely take place over the next year; the difference between criminal charges and conviction; the criminal trial process; resources available to the community, such as the Heal the Heart Core Coordinating Team; internal resources for staff; methods to provide regular, transparent, accessible updates to the City Council and the community; information available online at cityoftacoma.org/transform and cityoftacoma.org/useofforce; the internal investigation process, noting possible discipline, policy, or training changes; the need for swift action and a

thorough and accountable process; and which charging and investigation documents from the Pierce County Sheriff, Washington State Patrol, and the AGO have been received by the City to date.

Mayor Woodards presented the draft statement, read it aloud, and requested feedback from Council Members.

Discussion continued regarding the issues and concerns addressed; a request for more information on Washington Initiative 940 regarding law enforcement training, standards for use of deadly force, and investigations; appreciation for staff who helped draft the statement; purpose of the statement; the need for an open and transparent process; and promises made to the community.

MOTION: Deputy Mayor Blocker moved to approve the City Council statement regarding the Attorney General's charging decision related to the death of Manuel Ellis.
