> 9. <u>Rental Assistance</u>: **The rental assistance portal is open! Residents may find more information at** <u>https://www.piercecountywa.gov/7142/Rental-Assistance</u>. The program provides up to 12 months of assistance dating back to March 2020 and serves households up to 80% of Pierce County Area Median Income. Applicants may also qualify for utility assistance through the program. The City remains committed to reducing racial disparities in our service delivery and for this reason has a goal of providing at least 45% of the assistance to households headed by persons of color. In 2020, 638 households received assistance from the Tacoma Rental Assistance Program. Of those 638, 78% were households with the head of household identifying as a person of color. In 2021, 62% of households served to date are headed by persons of color.

In 2021, the City has provided 607 households with \$4,256,161 in rental assistance (this is an increase of 17 households and \$124,203 in assistance over last report) and 1,344 households with \$1,632,024 with utility assistance (this is an increase of 44 households and \$48,615 in assistance over last report). TPU has fully expended their portion of Emergency Rental Assistance 1 (ERA 1) funds and is now utilizing Emergency Rental Assistance 2 funds. We expect the remaining portion of our ERA 1 funds (dedicated to rental assistance) to be expended by mid-November. The City's Rental Assistance Fund at the Greater Tacoma Community Foundation has received 28 gifts totaling \$30,820.

Pursuant to the City of Tacoma March 12, 2020, state of emergency proclamation in response to COVID-19, made in accordance with Tacoma Municipal Code Chapter 1.10., contract awards for purchases must be approved by the City Manager or delegee.

#### **RECOMMENDATION SUMMARY:**

The City Attorney's Office requests approval to increase SAP Contract No. 4600014190 to Tupper Mack Wells PLLC ("Law Firm"), Seattle, Washington, by \$500,000, plus applicable taxes, for continued legal services with regard to the Washington State Department of Ecology's ("Ecology") preliminary determination to develop a Puget Sound nutrients general permit ("Permit") and for representation in litigation and appeals related to the Permit. The Law Firm represents the City in <u>Kitsap County v. Department of Ecology</u>, Pollution Control Hearings Board No. 20-005, <u>Birch Bay v. Department of Ecology</u>, Thurston County Cause No. 20-2-02539-34, <u>Tacoma v. Department of Ecology</u>, Pierce County Cause No. 21-204970-4, and <u>Birch Bay v. Department of Ecology</u>, Pollution Control Hearings Board No. 21-008c, and has been providing pre-litigation legal advice in anticipation of appeal of issuance of the Permit and will represent the City in an appeal if a Permit is issued. This increase will bring the contract to a cumulative total of \$800,000, plus applicable taxes. It is anticipated that litigation will continue through the next biennium and that an additional increase in the cumulative contract total will be needed in the next budget cycle.

#### STRATEGIC POLICY PRIORITY:

The work performed through this contract is intended to ensure that utility rate payer funds are strategically focused upon technology and improvements that will materially improve water quality in the Puget Sound and meet both water quality and growth management goals. Accordingly, this contract is in alignment with all the strategic policy priorities, and in particular will

- Assure outstanding stewardship of the natural and built environment.
- Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

#### BACKGROUND:

The Washington State Department of Ecology has issued a draft general nutrient permit applicable to most Puget Sound wastewater dischargers. The draft permit will impose limits



upon discharges of nutrients from Tacoma's wastewater treatment plants that will limit growth and require substantial investment in improvements to treatment plants to reduce nutrient loads. While the City supports Ecology's efforts to improve water quality in the Puget Sound, the City and other wasterwater treatment plant operators throughout the Puget Sound believe that more study and scientific analysis based upon accurate and relevant data is needed to determine the true scope and impact of discharge of wastewater treatment plant nutrient discharges upon water quality. Additionally, the City believes that Ecology has used a flawed process to develop the new proposed nutrient limits and permit requirements that violate the Federal Clean Water Act, the State Clean Water Act, and the State Administrative Procedure Act. The Law Firm has specialized knowledge and experience in the area of Environmental Law essential to the effectiveness of the City's efforts to address the merits of the Permit and the need for transparency in Ecology's chosen process.

**ISSUE:** The proposed amendment to the current legal services agreement is intended to ensure that the contract cumulative limit is sufficient to cover the anticipated legal costs through the current biennium. The proposed limit is based upon an estimate submitted by the Law Firm for legal services through the end of the current biennium. It is anticipated that a subsequent amendment will be necessary to cover the anticipated costs through the next biennium.

**ALTERNATIVES:** The Law Firm has specialized knowledge and experience in the area of Environmental Law and is actively representing the City in litigation with Ecology. The City Attorney's Office does not have the in-house resources that are necessary to effectively advocate on behalf of the City in the current litigation and appeals and anticipate appeal of the Permit. Accordingly, the only alternatives are to retain a different law firm which would necessarily increase the cost of legal services or abandon the City's current efforts. Our best guess is that changing law firms would add a minimum of \$100,000 to the proposed contract amendment. Abandoning the City's current efforts could lead to permit requirements that will double or triple utility rates and require between \$700 million and \$1 billion or more in improvements to the Tacoma wastewater treatment plants, and limit growth resulting in incalculable monetary impacts to the City and its residents.

**COMPETITIVE ANALYSIS:** The City Attorney has, in accordance with the July 30, 2021, Delegation of Authority Memo from the City Manager, determined that direct negotiation of this contract amendment is in the best interest of the City.

CONTRACT HISTORY: This contract was originally awarded to Tupper Mack Wells PLLC as a result of Direct Negotiation Waiver in February 2020 on SR2327420519. Amendment No. 1 to the Agreement, dated October 6, 2020, amended Exhibit "A," Assigned Attorneys and Staff and Billing Rates.

SUSTAINABILITY: The services provided through this agreement are intended to meet the City's vision of sustainability adopted pursuant to Resolution No. 38247 by ensuring that the burden of the general permit requirements upon the utility ratepayers will most efficiently use limited resources to impact water quality goals and will materially improve water quality to sustain future generations.

For your review and recommendation.

In accordance with TMC 1.06.256 (B), the City Attorney's Office requests a waiver of the competitive solicitation process and authorization to directly negotiate with **TupperlMacklWells**, **PLLC**, for legal representation in the matter of Kitsap County v Washington State Department of Ecology, PCHB No. 20-005 and in potential future litigation related to nutrient permit conditions imposed by Ecology in individual permits or a general permit, and for legal services related to Ecology's preliminary determination to develop a Puget Sound nutrients general permit, for an amount of \$500,000, plus applicable sales tax.

Direct negotiation approval constitutes a waiver of further competitive solicitation for amendments to the subject contract provided that any such amendment(s) shall be signed by personnel as authorized in the Delegation of Procurement Signature and Approval Authority memorandum. Contract totals shall not exceed \$200,000 without City Council or Public Utility Board approval as appropriate.

**EXPLANATION:** The Law Firm has the knowledge, experience, and expertise to provide legal advice and representation to the City in this matter.

#### JUSTIFICATION FOR DIRECT NEGOTIATION:

- 1. Ecology has issued nutirent requirements as part of a pemit issued to Kitsap County by the EPA. These requirements have the potential to impact nutrient permit requirements to all Puget Sound wastwewater dischargers, including Tacoma. Kitsap County filed an appeal of some of the permit conditions and the Clty of Tacoma has intervened in the appeal. It is necessary to retain outside counsel to represent the City in this appeal with secialized knowledge and experience in this practice area as soon as possible to ensure that the City can effectively support its position as an intervenor in the appeal and begin preparing for the hearing scheduled in October. Our office looked at three different firms before selecting this firm.



Pursuant to the City of Tacoma March 12, 2020, state of emergency proclamation in response to COVID-19, made in accordance with Tacoma Municipal Code Chapter 1.10., contract awards for purchases must be approved by the City Manager or delegee.

#### **RECOMMENDATION SUMMARY:**

The City Attorney's Office requests approval to increase CW2235033 to Ahlers Cressman and Sleight PLLC (Law Firm), Seattle, WA, by \$600,000, plus any applicable taxes, for the purpose of continued representation of the City in the matter of <u>State of Washington Department of Transportation v. City of Tacoma</u>, Pierce County Superior Court Cause No. 20-2-05528-5, relating to the I-5/Portland Avenue to Port of Tacoma Road, Northbound HOV Project, "T" Street Utility Corridor, as the matter proceeds to trial. This increase will bring the contract to a cumulative total of \$1,100,000, plus any applicable taxes.

#### STRATEGIC POLICY PRIORITY:

• Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

#### BACKGROUND:

A \$10,696,979 Claim for Damages (later increased to \$11,696,979) was filed against the City by the Washington State Department of Transportation (WSDOT), seeking reimbursement for WSDOT's alleged costs for the removal and replacement of underground facilities as part of the I-5/Portland Avenue to Port of Tacoma Road, Northbound HOV Project, "T" Street Utility Corridor (Project). WSDOT contends the City is liable for WSDOT's increased Project costs.

The parties were unable to reach resolution on this matter, and WSDOT filed a lawsuit against the City on March 16, 2020. Due to the fact that such issues as highway design and construction related damages are alleged, the Seattle law firm of Ahlers Cressman and Sleight PLLC has been retained for its expertise in litigating construction claims. The trial of this matter is scheduled for April 11, 2022 and it is anticipated that the trial will require two months to complete.



**ISSUE:** This is a document-intensive lawsuit. The litigation discovery process has produced 15,295 documents (141,316 pages), and the parties have disclosed 23 trial witnesses, most of whom are experts in the field of highway design, hydrology, geomorphology, pipe engineering, soils engineering and real property. Given Ahlers Cressman and Sleight PLLC's expertise in litigating similar document-intensive construction claims, it is necessary that the Law Firm continues to represent the City as this complex matter proceeds to trial. The requested increase to the Contract is needed to compensate the Law Firm for its ongoing representation of the City through the trial.

If WSDOT were to prevail, the City would be liable for a payment of the \$11,696,979 claim by WSDOT and possibly a claim by the Attorney General's Office for an additional \$1,000,000 in attorney's fees.

**ALTERNATIVES:** The alternative is for City Attorney's Office personnel to defend the City in this matter. However, current internal staffing levels preclude the City Attorney's Office participation as trial counsel in this matter. Furthermore, the Law Firm's specific expertise in litigating these types of document-intensive construction related matters will be more cost effective for the City.

**COMPETITIVE ANALYSIS:** The Law Firm was selected for its expertise in litigating complex, document-intensive construction claims, and has the knowledge, experience, and expertise to provide ongoing legal advice and representation to the City in this matter.

**CONTRACT HISTORY:** This contract was originally awarded to Ahlers Cressman and Sleight PLLC as a result of a Direct Negotiation Waiver in February 2020 under CW2235033. The contract has been amended twice previously for the purposes of updating the Law Firm personnel authorized to work on this matter and to apply current hourly rates for such personnel.

SUSTAINABILITY: No sustainability factors were considered.

Direct negotiation approval constitutes a waiver of further competitive solicitation for amendments to the subject contract provided that any such amendment(s) shall be signed by personnel as authorized in the Delegation of Procurement Signature and Approval Authority memorandum. Contract totals shall not exceed \$200,000 without City Council or Public Utility Board approval as appropriate.

**EXPLANATION:** The defense of the case requires an understanding of the complex cost issues involved in an hignway construction project. The practice area and expertise of the law firm Ahlers, Cressman & Sleight, PLLC of Seattle, Washington, is almost exclusively construction litigation, would assist in preparing a damages defense against WSDOT's claim.







#### **BACKGROUND:**

Each year the Mayor's Youth Commission of Tacoma (MYCT) elects a 10-member leadership team: a Chair and Vice-Chair of the entire Commission, as well as a Chair and Vice-Chair of each of the four committees. The leadership team is confirmed by the City Council. The leadership team meets twice each month and hosts a General Assembly meeting once per month.

The Mayor's Youth Commission met virtually on June 19, 2021 to elect a new leadership team to represent all members of the Commission and have submitted their names for confirmation. At this time, seven individuals were recommended to the City Council for confirmation. They were appointed on July 13, 2021. Three additional spots remained open. On September 1, 2021 the seven members voted unanimously to recommend Shae Dolan and Chloe Mau be appointed to the MYCT. One final spot remains open.

#### **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

The recruitment for new leadership was led by the Mayor's Youth Commission, with support from the Commission Liaison from the City, and from the Foundation for Tacoma Students. The primary method of recruitment was through emails to existing members, social media campaigns through the Commission's Instagram, and through partner channels of the Foundation for Tacoma Students and the City.

#### **2025 STRATEGIC PRIORITIES:**

**Education:** *Equity Index Score*: High Opportunity Increase the number of quality out of school time learning opportunities distributed equitably across the city.

#### Civic Engagement: Equity Index Score: Moderate Opportunity

Increase the number of residents who participate civically through volunteering and voting. Elected officials, boards, commissions, and volunteer leadership will reflect the diversity of the Tacoma community.

The Mayor's Youth Commission provides opportunities for out of school learning opportunities and engagement with city and community leaders in different areas of the city. As a commission that engages middle and high school students, the Mayor's Youth Commission provides the City an opportunity to get young people engaged with government thus improving many of the Civic Engagement indicators.

#### **SUMMARY AND PURPOSE:**

A resolution affirming the City of Tacoma supports the use of data-informed tools, such as community prioritization, to prevent displacement of local residents and strongly encourages the City's partners to use these tools to ensure more residents are able to stay in Tacoma with a focus on households from "low" and "very low" opportunity areas of the City as defined by the Equity Index as well as Black, Indigenous, and People of Color (BIPOC) households; and directing the City Manager to evaluate options to assist in preventing displacement of residents.

#### **COUNCIL SPONSORS:**

Mayor Victoria Woodards, Council Member Kristina Walker, and Council Member Catherine Ushka

#### **BACKGROUND:**

Displacement of long-time residents in Tacoma, especially in "low" and "very low" opportunity neighborhoods as defined by the City's Equity Index and among BIPOC households, has been an ongoing problem. Tacoma's housing market is booming and rents are increasing faster than wages. Low-income and BIPOC renters in up-and-coming areas in the city are at-risk of displacement.

Community prioritization for housing allows housing providers to prioritize certain applicants, based on data that shows a disproportionate impact of displacement on those applicants, when leasing or selling units in communities at high risk of displacement.

Direct displacement of current residents occurs when residents can no longer afford to remain in their homes due to rising rents or property taxes, or residents are forced out due to causes such as lease non-renewals and evictions to make way for new development, or physical conditions that render their homes uninhabitable. <sup>1</sup> Indirect displacement occurs when housing being vacated by low-income residents are no longer affordable to other low-income households. <sup>2</sup>

According to the Home in Tacoma Housing Action Plan, incomes have not kept up with housing costs. From 2016 to 2019, median rent increased by 21% while median renter income increased by only 12%.<sup>3</sup> Similarly, the median home value of owner occupied housing increased by 44% compared to a 22% increase in median income for

owner households. It is becoming increasingly difficult for renters to afford to rent or buy in Tacoma as wages fail to keep up with rising housing costs.

The Affordable Housing Action Strategy (AHAS) is the City's plan to address the housing affordability crisis. The AHAS outlines that many Tacoma residents expressed concern around the potential effects of higher housing costs—namely that changing market conditions could price out longtime residents and community-based businesses from their neighborhoods or make it difficult to stay in or buy a home within Tacoma.<sup>4</sup>

On June 30, 2020, the City Council passed Resolution No. 40622 that directed the City Manager to prioritize antiracism in the evaluation of new policies and programs, as well as the sustained and comprehensive transformation of existing services. <sup>5</sup>

On November 24, 2020, the City Council passed Resolution No. 40697 that directed the City Manager to use the Down Payment and Foreclosure Assistance disparity study funded in the proposed 2021-2022 Biennial Budget to identify disparities caused by historic racism or displacement caused by gentrification that resulted in disproportionate homeownership and the inaccessibility of communities of color, and particularly Black communities, to build generational wealth.<sup>6</sup>

Households in Pierce County who identify as BIPOC are disproportionately impacted by housing precarity and displacement. Precarity is defined as "resilience to economic and environmental shocks and is measured as a composite score of low-income displacement and eviction risk combined with unemployment data and COVID-19 infections."<sup>7</sup> According to the Supporting Partnerships for Anti-Racist Communities (SPARC) report, Black/African American people represent 26.3% of the HMIS population in Pierce County, despite only making up 6.6% of the general population in Pierce County. <sup>8</sup> According to the Housing Precarity Risk Model<sup>9</sup> from the UC Berkeley Urban Displacement Project, 24% of all renters (29,265 out of 122,460) in Pierce County live in high-precarity neighborhoods. <sup>10</sup> Among all Black or African-American renters in Pierce County, 39% live in high-precarity neighborhoods and the percentage for Asian and Latinx renters is just below this. <sup>11</sup> Among all White renters, only 18% live in high-precarity neighborhoods in Pierce County. <sup>12</sup>

The City's historically Black and African-American neighborhood, Hilltop, is at particular risk of residents being displaced – and many residents have already left the 98405 zip code. A transportation study from the Federal

Transit Administration titled, Proposed Strategies to Increase Affordability & Stem Displacement on Hilltop (2017), found that "many Hilltop residents, particularly renters, cannot keep pace with rising housing costs." The study found that 45% of Hilltop households are spending more than 30% of their income toward housing costs, compared with 39% citywide. <sup>13</sup> According to a representative of the Tacoma Urban League quoted by the Seattle Times, 35% of African Americans moved out of the Hilltop neighborhood between 2010 and 2015. <sup>14</sup>

The City has a legacy of policies and practices that have compounded the issue of displacement for Tacoma residents, including, but not limited to:

- Racially restrictive residential redlining
- Racially restrictive housing covenants
- Disinvestment in non-white neighborhoods, especially historically Black neighborhoods
- Urban revitalization starting in the 1990s through current development of high-opportunity transit in Hilltop
- Maintaining low housing supply through exclusive single-family zoning in roughly 75% of Tacoma

These policies have led to staggering statistics for Pierce County:

- #1 in state for eviction risk, with 18% of Black adults being named in an eviction<sup>15</sup>
- #1 in state for unemployment rate and change in unemployment (2019-20)<sup>16</sup>

The Equity Index is a tool used by the City of Tacoma to identify disparities in the city based on census block group data.<sup>17</sup> The Equity Index uses 29 indicators within five social determinant categories based on the Tacoma 2025 Strategic Plan to determine where the greatest community needs are located. Census block groups' score are labeled on a scale from "very high" to "very low." Areas with the highest opportunity are labeled "very high" and areas with the lowest opportunity are labeled "very low." Tacoma's Equity Index was generated by the Kirwan Institute for the Study of Race & Ethnicity for Tacoma's Office of Equity and Human Rights and is applied across all City Departments, including being considered in every legislative proposal.

## **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

Those individuals potentially affected by this proposal include people at high risk of displacement in Tacoma, specifically households from "low" and "very low" opportunity areas of the City as defined by the Equity Index as well as Black, Indigenous, and People of Color (BIPOC) households, and those residents who have been disproportionality impacted by gentrification. Staff from the City's Community and Economic Development Department and Affordable Housing Action Strategy team have been working closely to learn the needs of
