### **Briefing Items**

5. 22-1295 South Tacoma Groundwater Protection District - Consideration of a Moratorium [Stephen Atkinson, Principal Planner, Planning and Development Services]

At approximately 4:40 p.m., Stephen Atkinson, Principal Planner, Planning and Development Services, presented the proposed moratorium for the South Tacoma Groundwater Protection District (STGPD), including the Planning Commission's (PC) recommendations, noting reasons for a moratorium, suggested duration, and the work plan; and the potential schedule.

Discussion ensued regarding the PC's recommendations; service and repair for both regular and industrial vehicles; current regulations; metal recycling and auto wrecking; building a canopy in the stormwater runoff areas; possible effects of implementing the moratorium; site improvements allowed under the moratorium; underground storage tanks, noting maintenance, replacement, and improvements and upgrades allowed; and next steps.

MOTION: Vice Chair Hines moved to forward the Planning Commission's recommendations regarding a moratorium on certain uses within the South Tacoma Groundwater Protection District, not to include vehicle service and repair and industrial vehicle service and repair, and to also consider language around potential replacements or improvements to underground tanks that will promote environmental protection, to the full City Council for consideration.
