Council Member Hines, Chair of the Government Performance and Finance Committee, reported at the May 2, 2023, meeting, the Committee considered and recommended volunteers to serve on the "For" and "Against" Committees for Proposition No. 1 concerning the restoration of the City's emergency medical services property tax levy, and received presentations on the Sprint telecommunications franchise agreement and the SAP Now! technology project; and at today's meeting, the Committee conducted interviews for the Public Utility Board. He concluded by stating the next meeting will be a joint meeting with the Audit Advisory Board, held in a hybrid format on June 6, 2023, at 10:00 a.m., and will include interviews for the Board of Ethics, and presentations on the 2021 Transportation Benefit District exit financial and accountability audit and 2022 audit entrance conference, and phase 2 of the accessory dwelling unit accelerator.



Council Member Ushka announced that the Planning and Development Services (PDS) Long-Range Planning team earned an Excellence in Planning award in the category of implementation for the McKinley Hill Neighborhood Plan from the American Planning Association Washington Chapter and the Planning Association of Washington, noting the award acknowledges the plan's focus on quick implementation. She concluded by stating that the plan will continue with support from the Neighborhood Planning Program and partnership with the McKinley Hill neighbors, and was developed after more than a year of community engagement; that Tacoma is one of six state-wide projects to receive an award; and expressed appreciation to PDS staff.
