An ordinance amending Title 9 of the Municipal Code, relating to Public Ways, by repealing Chapters 9.18, 9.19, and 9.20 in their entirety and replacing Chapter 9.20 with a new chapter entitled "Urban Forestry", to establish permit requirements and related regulations for pruning, removal, and planting of street trees, establish policies and procedures for discretionary review of requests to prune trees on public property, establish a heritage tree program, and provide for enforcement and penalties for violations; amending Title 1 of the Municipal Code, relating to Administration and Personnel, by amending Chapter 1.23 of the Municipal Code, entitled "Hearing Examiner", to provide for administrative appeals; and establishing effective dates.

REPORTS BY THE CITY MANAGER

City Manager Pauli reported the City has activated its inclement weather response with Holy Rosary Church opening an additional 120 beds and the Homeless Engagement Alternatives Liaison Team is equipped with supplies for those they are connecting with additional services. She concluded by providing a follow up on the virtual Rental Housing Code event that occurred on December 4, 2023, stating the City's priority and purpose is to support the voice of the people; Measure 1 was certified and as of December 8, 2023, it will become a law in the City; and this code is structured to provide tenants and property owners the right to take civil action and seek enforcement in the court of law.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Community Vitality and Safety Committee

Council Member Ushka, Chair of the Community Vitality and Safety (CVS) Committee, reported the Committee met once since the last report; the October 26, 2023, meeting was cancelled; and at the November 9, 2023, meeting the Committee held interviews to fill vacancies on the Community's Police Advisory Committee, reviewed applications to fill youth vacancy positions on committees that report to CVS, and received an informational briefing on the rental property data tracking focusing on the City's efforts to create a system to capture data. She concluded by stating the next meeting will be held in a hybrid format on December 14, 2023, at 4:30 p.m., and will include briefings on Rental Housing Code research and amendments to Municipal Code Chapter 8.17, False Reports of a Crime.

Council Member Walker wished everyone happy holidays, noting the start of Hanukkah.
