2024 Update to the One Tacoma Comprehensive Plan [Stephen Atkinson, Principal Planner, Planning and Development Services]

At approximately 4:33 p.m., Stephen Atkinson, Principal Planner, Planning and Development Services, presented the 2024 update to the Comprehensive Plan, including an agenda.

Vice Chair Diaz arrived here, at 4:36 p.m.

Atkinson continued by presenting the regional planning framework; goals of the Washington State Growth Management Act; Vision 2050, noting new items; local additions, noting long-range planning efforts, new programs, and other City of Tacoma initiatives; overarching themes; opportunities, noting level of service standards, equitable distribution of services and facilities, 20-minute neighborhoods, and the Transportation Master Plan; and an update on Comprehensive Plan milestones.

Discussion ensued throughout regarding transportation safety; commercial displacement; engagement with other organizations, such as Metro Parks Tacoma, Tacoma Public Schools, Port of Tacoma, and Joint Base Lewis-McChord; public outreach and engagement; intersection with the Home in Tacoma (HIT) Project and Tacoma 2025; health equity and life expectancy goals; transportation and community safety; and the concept of live-work units.
