# Joint City Council / Tacoma Public Library Briefing Item

1. <u>23-0094</u> Tacoma Public Library 2022 Annual Report

At approximately 12:01 p.m., Kate Larsen, Director, TPL, presented the TPL 2022 annual report, including their mission. She continued by outlining TPL's strategic priorities and related efforts, including equity and access; learning, creativity, and innovation; investment in youth; and cultivating and engaging the community.

Council Member Diaz arrived here, at 12:16 p.m.

Larsen concluded by outlining the strategic priorities and related efforts related to being responsible and resilient; and expressed appreciation for the TPL Foundation Board of Directors and the TPL Board of Trustees. Discussion ensued regarding programs and resources, noting Tacoma Reads, archiving local stories, and continuing education; appreciation for staff and the TPL Board; goals; grant funding; options to expand library hours of operation; partnerships; equity; and the importance of library branches to the community.

#### **Other Items of Interest**

2. <u>23-0102</u> State v. Blake Presentation Follow-up Discussion

Mayor Woodards made opening remarks regarding the Washington State Supreme Court's State v. Blake decision, noting past City Council discussion at the January 24, 2023, study session, and options to arrange for future discussions as needed; and that she has met with Pierce County Prosecuting Attorney Mary Robnett on this topic. Sonja Hallum, Chief Government Relations Officer, City Manager's Office, provided responses to questions from last week's discussion of the State v. Blake decision, including available treatment programs and processes, funding resources for indigent services, City funding levels, possible impacts of the proposed legislation, and confirmation that the American Civil Liberties Union is not in support of any of the proposed legislation.

Discussion ensued regarding treatment programs, funding resources, diversion decisions, how the City and Pierce County courts handle different charges, system capacity, and options to coordinate with Pierce County.

Hallum presented an overview of Resolution No. 41134, related to amending the City's 2023 State Legislative Agenda, which is on tonight's meeting agenda, noting that it includes the City Council's position on controlled substance laws, including misdemeanor charges, removing charges from the record, and treatment facilities; immigration-related bills; and support for the Pierce County Council's legislative agenda items related to funding requests for permanent supportive housing and the Pierce County Ferry.
