Call to Order

Mayor Woodards called the study session to order at 12:00 p.m.

Briefing Items

1. <u>23-0452</u> Historic Preservation Annual Update

At approximately 12:01 p.m., Reuben McKnight, Historic Preservation Officer, Planning and Development Services (PDS), the Historic Preservation Program annual update, including an overview and background.

Council Member Daniels arrived here, at 12:02 p.m.

McKnight continued by reviewing the 2022-2023 historic preservation goals and initiatives; program highlights and achievements; and the Landmarks Preservation Commission year in review, noting activities, objectives, and major projects. Susan Johnson, Historic Preservation Analyst, PDS, presented the events for Historic Preservation Month, noting the theme of "People Saving Places". McKnight concluded by summarizing upcoming 2023 programs and events; 2023-2024 program initiatives; tribal coordination, noting interim and long term steps; and the Comprehensive Plan and code. Discussion ensued regarding historic nominations, noting the difference between residential and commercial nominations; redevelopment and renovations; increased engagement with the Puyallup Tribe of Indians; historic programming; community partner opportunities; and design guidelines in historic districts.

2. <u>23-0453</u> Tacoma Anchor Network's Update

At approximately 12:26 p.m., Jacques Colon, Chief Strategy Officer, Office of Strategy, provided opening remarks on the Tacoma Anchor Network (TAN), including development of the Tacoma 2025 strategic plan; steps to complete shared goals, noting livable wage jobs, education, and economic development; the role of the City and the TAN, noting the desire to come together for a resilient local economy; and appreciation for staff, elected officials, and TAN members. Danny Fisher-Bruns, independent consultant, presented the TAN update, including an agenda; the definition of an anchor institution; and examples of anchor institutes, including Cleveland, Ohio and Newark, New Jersey. He continued by providing details about the TAN, including a brief history; current members; the vision; the mission; current working groups; 2023 work plans within the working groups, noting as the work gets deeper, the TAN partners are driving the work; and concluded by stating the group is having challenging conversations, and benefiting from shared leadership. TAN partner representatives Doug Baxter-Jenkins, Community Health Division Director, Virginia Mason Franciscan Health, and Abigail Vizcarra Perez, Equity Outreach Program Coordinator, Metro Parks Tacoma, provided perspectives on the value of working as a network, including using TAN as a conduit to move things forward, noting the COVID-19 pandemic; bringing large institutions together to build trust; making conversations possible; identifying niche roles through an extensive network; sharing strategies to build tools; and help create and effect change, noting pride in TAN and that members rely on it every day. Colon concluded by acknowledging and thanking all TAN partners, and emphasizing that the TAN brings people together to best serve the community and provides an established venue to bring shared challenges and priorities, and allows partners to develop their coordination together.

Discussion ensued regarding regional collaboration, how to join TAN, support for TAN's role in addressing community concerns, and appreciation for Deputy Mayor Walker's role in TAN.
