Briefing Item

1. [23-0531](#) Six-Year Comprehensive Transportation Improvement Program

At approximately 12:01 p.m., Josh Diekmann, Interim Director, Public Works (PW), provided a brief background and introduced Jennifer Kammerzell, Assistant Division Manager, PW. Kammerzell presented an overview and background on the Six-Year Transportation Improvement Program (TIP), noting the TIP currently has 119 projects and how the TIP coincides with the City's budgeting process; proposed amendments, noting eight added projects, six bridge projects, grant opportunities, and a City grant match; highlighting five projects, East 34th Street deck repairs and seismic retrofit; Sheridan Avenue complete streets; pedestrian accessibility improvements; East 64th Street phase two and three; and Hilltop Links to Opportunity streetscape; health, equity and sustainability analysis; and next steps.

Discussion ensued regarding appreciation for the focus on certain areas and priorities; priority of Hosmer corridor becoming more walkable and pet friendly; communication with community; proposed amenities; equity tools; application for grants; missing gap on Portland Avenue; walking safety; communication with Pierce Transit; prioritizing projects; partnering with Metro Parks and Tacoma Public Schools; and engagement with larger government agencies.
