Chair Ushka called the meeting to order at 4:30 p.m.

[Doris Sorum, City Clerk]

At approximately 4:32 p.m., Doris Sorum, City Clerk, informed the Committee they would be interviewing six applicants for the Tacoma Community Redevelopment Authority Board (TCRA), one of which is seeking reappointment; and that there are five positions available, including one Contractor Representative, two At-Large positions, and two Attorney Representatives; but there are only four positions to consider, as there is only one applicant that qualified for the Attorney Representative position. She further stated that the incumbent seeking reappointment would not be interviewed as he would like to be considered based upon his TCRA experience and written documentation.

Council Member Hines arrived here, at 4:32 p.m.

The Committee interviewed Azaria Azene, Amanda DeShazo, Jessica Roberts, Libby Williams, and Barb Commare; and reviewed Daniel Montopoli's written documentation.

Discussion ensued regarding clarification on the districts that applicants live in; the applicant seeking reappointment, noting term limits and the request for a special extension of the term; the applicants' qualifications; and demographics of TCRA.

2023 Annual Action Plan

[Felicia Medlen, Housing Division Manager, Community and Economic Development; Jason McKenzie, Resource Manager, Neighborhood and Community Services]

At approximately 5:33 p.m., Felicia Medlen, Housing Division Manager, Community and Economic Development, presented the 2023 Annual Action Plan, including an overview; 2023 Community Development Block Grants (CDBG) allocations, noting housing, economic development, and public services; Emergency Solutions Grant allocations, noting external contracts; HOME Investment Partnership Program (HOME) allocations; and next steps.

Discussion ensued regarding the potential federal government budget cuts to housing and what that means for Tacoma, the 2024 budget, the housing programs that are funded from the HOME allocations, TCRA's role in allocating funding, and clarification on the consortium with the cities of Tacoma and Lakewood.


