3. 23-0489 Human Services Commission Interviews [Doris Sorum, City Clerk]

At approximately 4:34 p.m., Doris Sorum, City Clerk, informed the Committee that they would be interviewing four applicants for the Human Services Commission, that Naomi Wilson is seeking reappointment, that seven positions are available, and no applications were received for the Youth Member position.

The Committee interviewed Naomi Wilson, Kimberly Ellefson, and Liz Ryan. Patricia Borgand did not participate.

Discussion ensued regarding applicants' qualifications, noting residency; and the suggestion to solicit additional applications.

4. <u>23-0490</u>

Community Safety Plan Update [Jacques Colon, Chief Strategy Officer, Office of Strategy]

At approximately 5:02 p.m., Jacques Colon, Chief Strategy Officer, Office of Strategy, presented an update on the City's Community Safety Plan (CSP), including an agenda; purpose, noting what makes people feel safe and the need for a more coordinated approach; and scope, noting venues where the City gathered feedback from the community. He further detailed the CSP scope, including social, economic, and environmental conditions; prevention efforts with priority populations; alternative responses; improving and transforming public safety departments; and off-ramps, noting diversion, restorative justice, and reintegration. He continued by reviewing next steps and a timeline; the CSP community engagement process; examples of implementation models, noting the City's Affordable Housing Action Strategy for internal groups and the Newark Public Safety Collaborative for external coordination; and questions related to plan development, noting data and research, engagement and coordination, and outcomes and implementation.

Discussion ensued regarding the approach, scope, and complexity of the CSP; next steps, noting possible actions and goals; the action strategy framework; highlighting the disproportionate impacts on people of color; data sources; outreach and the purpose of engagement; and a request for information to be provided in other formats and languages.
