Council Member Walker stated the Committee has met three times since the last report and at those meetings the Committee held a panel discussion on the status of housing foreclosures in Tacoma, current efforts to address the problem, and recommendations to resolve challenges going forward; heard a presentation on the brand new Speaker's Bureau, which will provide an opportunity for established community groups to request subject matter expert presentations on a variety of topics; learned about the proposed new conservation district overlay to be located in the West Slope; and heard an update on the Community Cleanup Program. She stated the next meeting is scheduled for June 16, 2014, at 4:30 p.m., and will include presentations on Derelict Buildings and the Minimum Buildings and Structures Code.
