REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax stated the Department of Ecology's Water Quality Program announced availability of the State Fiscal Year 2016 Draft Funding Offer List and Intended Use Plan for public review and comment last Thursday, February 11, 2015. He noted the draft list describes how the Department of Ecology plans to use state and federal dollars to fund projects focused on improving water quality across the state.

He then announced the City received \$5 million in storm water financial assistance funding, which is the maximum allowed per municipality. He noted this is another example of how Tacoma and the Center for Urban Waters are on the forefront of innovative proposals for water quality and setting the example for the entire country on how green infrastructure can be integrated into the community sustainably.

Mr. Broadnax stated there were six projects funded, including the South Tacoma Way Business District, the Pearl Street Business District, the 40th Street Green Infrastructure project, the Madison and Monroe Permeable Neighborhood project, the Bennett Street Pervious project, and the Prairie Line Trail Treatment Retrofit project. He thanked the team of engineers and environmental scientists at Urban Waters for their hard work in securing these moneys to be spent improving water quality in the City, while providing clear economic benefits to the construction community.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Economic Development Committee

Council Member Campbell, Chair of the Economic Development Committee, stated on December 9, 2014, the Committee received an update on the Urban Waters Innovation Partnership Zone from the Economic Development Board, University of Washington-Tacoma, Washington State University, and the Community and Economic Development and Environmental Services departments; an update on disposition of Tier 1 properties; and the results of testing that was done with the material that can potentially be used for the Warhol flower on the Tacoma Dome roof. He then stated on January 13, 2015, the Committee reviewed the end-of-year report for the Committee that provided a breakdown of briefings, requests for action, and appointments. Chair Campbell noted on January 27, 2015, staff from the Community and Economic Development department, Port Commissioner Clare Petrich, and community members provided a proposal to adopt Hvar, Croatia as a new sister city, which the Committee voted to forward the proposal to the full council for consideration given the long-standing history of the Croatian population in Tacoma. He then noted on February 10, 2015, the Committee discussed recent activities of the City Events and Recognitions Committee, and the role the Committee plays in planning future events. He added the next meeting will be February 24, 2015, and will include an update from the Foss Waterway Development Authority, and a report on the economic indicators for the fourth quarter of 2014.

Deputy Mayor Boe provided information on a number of performing arts events in Tacoma this weekend, including the Tacoma Musical Playhouse Family Theater, the Tacoma Youth Symphony Young Artists Orchestra, the Three Divas by the Northwest Sinfonietta at the Rialto Theater, the Grand Cinema Academy Awards Party at the Theatre on the Square, and the Brahms Violin Concerto at the Rialto Theater.
