2. <u>16-0758</u> Update on Transportation Master Plan Metrics & Accountability [Jennifer Kammerzell, Engineer, Public Works]

At approximately 4:34 p.m., Jennifer Kammerzell, Public Works, provided an overview of the Transportation Master Plan metrics and accountability, including background information, system performance measures, issues, targets, and next steps.

Discussion ensued throughout regarding grant applications, performance measures, proposed targets, the Environmental Action Plan, targets, data, and climate pollution reduction.

3. 16-0759 Urban Forestry [Mike Carey, Management Analyst III, Environmental Services]

At approximately 4:50 p.m., Jim Parvey and Mike Carey, Environmental Services (ES), provided an overview on the Urban Foresty Program, including program history, management plan, internal and external coordination, benchmarking research, new management plan, service level, and concluded by discussing next steps.
