Joint City Council/Public Utility Board Briefing Items

1. 16-0788 Click! Updates

At approximately 12:08 p.m., Bill Gaines, Director, Tacoma Public Utilities (TPU), introduced Tenzin Gyaltsen and Chris Robinson, TPU. Mr. Gyaltsen discussed the Click! Engagement Committee, and provided a summary of findings and recommendations of the Committee. Discussion ensued regarding the potential funding models.

Council Member Thoms arrived here, at 12:30 p.m.

Mayor Strickland provided an overview of Click! Network including background, timeline, the All-In model, the Click! Engagement Committee, key issues, policy considerations, potential models and next steps. Discussion ensued regarding the future of Click! Network, the financial analysis, the Committee process and findings, future trends in broadband, internet as a utility, potential funding models, the biennial budget, potential legal risks, protecting the citizens, number of current cable customers, growth models, and market shares.

Mayor Strickland concluded by reading a letter submitted by Click! Engagement Committee Member Janine Terrano. Discussion continued regarding the Committee meetings, a proposed ballot measure, proposed ratepayer fees, the timeline, and a recently held Community Solar Project held by TPU.

T.C. Broadnax, City Manager, provided information on a recently received grant related to streetscape, design and planning efforts associated with the LINK Light Rail Expansion in the Hilltop neighborhood. He stated a citizen committee will be created to support the project that will be comprised of 13 members.

Discussion ensued regarding the inclusion of Centro Latino on the citizen committee.

2. 16-0815 Equity and Empowerment Biennial Budget Planning

At approximately 1:03 p.m. Julie Nelson, Director, Government Alliance on Race and Equity, discussed advancing racial equity relative to the budget process, including background information for the Government Alliance on Race and Equity, values and realities, history of government and race, current context of race, national best practice, equity versus equality, racial inequity in the United States, defining racial equity, explicit versus implicit bias, goals, equity in municipal budgeting, budget equity and empowerment, and considerations for the City Council.

Discussion ensued regarding challenges, inequities, timelines and statistics relative to bias.
