Mayor Strickland called the study session to order at 12:07 p.m.

# **Briefing Items**

1. <u>16-1036</u> Budget Work Session - General Fund Revenues and Cost Drivers Presentation

At approximately 12:08 p.m., Tadd Wille, Director, Office of Management and Budget, provided an overview of General Fund revenues and cost drivers, including 2017-2018 General Fund revenues, revenue projection development, all General Fund revenues, property tax, business tax, major business tax declines and increases, sales tax, utility tax, other taxes, charges for services, and revenues, rate an fee updates, and General Fund reserves.

Discussion ensued regarding one time revenues, increases in tax revenues, implementation of fee updates, non-taxable data, utility and sales taxes, and the proposed increase in business license fees.

Joy St. Germain, Director, Human Resources, discussed salaries and benefits, including employee demographics, salaries and benefits as a percentage of the budget, average annual wage increases, employee health and welfare benefits, 2017-2018 healthcare expenses, the Patient Protection and Affordable Care Act, health care cost continuum, health care goals, and next steps.

Tim Allen, Director, Retirement, provided an overview of the Law Enforcement Officers' and Fire Fighters' and Tacoma Employees' Retirement Systems, including background information, contribution rates, recent action taken, and next steps.

#### 2. <u>16-1037</u> Budget Work Session - Tacoma Police Presentation

At approximately 1:05 p.m., Chief Donald Ramsdell, Tacoma Police, provided an overview of the Tacoma Police Department, including the mission statement, organizational structure, 2015-2016 major accomplishments, the Project PEACE initiative, goals, diversity, positive relationship with youth, community safety, and public trust and community relationships. He reviewed the proposed 2017-2018 Biennial Budget, including patrol staffing, graveyard shift, crimes against persons and property, crimes against society, calls for service, citizen self service, budget enhancements, and equity in budgeting.

Discussion ensued regarding crimes against persons, proposed new positions, budget savings, typical amount of overtime cost for patrol officers, vacancies, and property crime prevention.

The study session recessed at 2:36 p.m., and reconvened at 2:45 p.m.

3. <u>16-1038</u> Budget Work Session - Tacoma Fire Presentation

At approximately 2:47 p.m., Chief James Duggan, Tacoma Fire, provided an overview of the Tacoma Fire Department, including the mission statement, organizational structure, 2015-2016 accomplishments, and goals. He reviewed the proposed 2017-2018 Biennial Budget, including revenue, response model, and enhancements.

Discussion ensued regarding accreditation, additional positions, vacancies, total number of calls in 2015, number of current budgeted positions, overtime analysis, reimbursable costs, and medical response times.

4. <u>16-1039</u> Council Consideration Request - Third Party Consultant for Click! Analysis and Audit

At approximately 4:07 p.m., Council Member McCarthy presented a Council Consideration Request relative to hiring a third party consultant to audit, analyze, and establish a reasonable methodology for cost allocation between Tacoma Power and Click!, and to evaluate the expansion of Click! Network in the context of an evolving telecommunications and cable industry.

Discussion ensued regarding policy direction.
