#### **Special Meeting**

#### Call To Order

Chair Mello called the special meeting to order at 2:03 p.m.

### **Briefing Items**

#### 1. <u>16-1011</u>

North 21st Design [Joshua Diekmann, Public Works Division Manager, Public Works]

At approximately 2:04 p.m., Joshua Diekmann, Public Works, provided an overview of the North 21st Street Power Pole Replacement and Roadway Project, including future forecasts, travel patterns, non-motorized modes of transportation, traffic analysis, proposed traffic lane and bicycle lane options, westbound lane transition at Proctor Street, plan view concept, hybrid option, comparison of proposed option 1 and option hybrid 3A and concluded by discussing next steps.

Discussion ensued regarding the refined options presented, impacts to emergency response vehicles, pedestrians, traffic flow, timeframe, benefits among new and current structures, hybrid option 3A, possible overbuilding versus underbuilding, safe bike lanes, increase of traffic volumes and speeds, studies performed, transit priorities, regulated traffic lanes, road design, pole placement, staff recommendation, continued growth, road systems, population growth in the mixed-use center, impacts on models and future models, goals, trends, arterial impacts, infrastructure, road transportation network, projections, carpooling, bus routes, pedestrian safety, additional law enforcement for speeding, the Transportation Master Plan, and traffic ratings.

Discussion continued regarding safe roads, speed enforcement, police enforcement, pole placement on North 21st Street, number of lanes, flexibility of option hybrid 3A, density, option 3, major arterial connections, traffic, Tacoma's vision, the Transportation Master Plan, implementing policies, advancing communities, potential pedestrian island over growth, and medians.

MOTION: Council Member Thoms moved to recommend hybrid option 3A and option 1 to the full City Council for consideration.

ACTION: Voice vote was taken and carried. The motion was declared adopted.

 16-1012 Sustainable Materials Management Plan [Jim Parvey, Assistant Division Manager, Environmental Services]

At approximately 3:32 p.m., Jim Parvey, Environmental Services (ES), introduced Gary Kato, ES, Marc Daudon, Cascadia Consulting, and Phil Coughlin, Herrera Consulting. Mr. Parvey provided an overview of the Sustainable Materials Management Plan, including background information,

purpose, a status update on solid waste management, current conditions, recycling and yard waste normalized for populations from 1992-2015, overall generation and recovery, overall disposed waste, and residential and commercial food waste in 2009 versus 2015. Mr. Kato discussed the 70 percent diversion goal, the 4 phases, recovery estimates, and programs. Mr. Parvey concluded by discussing the next steps.

Discussion ensued throughout regarding wood waste from construction sites, food waste, single and multi-family waste containers, recycling containers for multi-family and the commercial sector, paper contaminants into the waste stream, infrastructure, rate differentials, goals in phase 1 and 2, material recovery facility (MRF) data, adding a resource conservation manager position, education, MRF costs, new state requirements, waste stream audits, and future audits.
