### Call to Order

Deputy Mayor Thoms called the study session to order at 12:09 p.m.

### Briefing Items

1. [17-0394](#) Tacoma Link Project Update

At approximately 12:10 p.m., Kurtis Kingsolver, Public Works Director, provided brief opening remarks and introduced Madeleine Greathouse, Sound Transit. Ms. Greathouse provided an update on the Tacoma Link Project, including funding updates, agreements, project status, final design, station design, operations and maintenance facility design, station naming process, top station names, community outreach, the Sound Transit Art Program and goals, the chosen artist, and next steps.

Discussion ensued regarding funding sources, federal funding, station naming, and the placement of stations.

2. [17-0395](#) Six-Year Transportation Improvement Program

At approximately 12:27 p.m., Mr. Kingsolver provided brief opening remarks and introduced Diane Sheesley and Jennifer Kammerzell, Public Works. Ms. Sheesley provided an update on the Six-Year Comprehensive Transportation Improvement Program (TIP), including background information, process, and program revisions. Ms. Kammerzell discussed projects to be added, including East Portland Avenue safety improvements, Hilltop and South Downtown pedestrian improvements, Pearl Street lighting and pedestrian improvements, Safe Routes to School improvements, and

school speed zone beacons.  
Ms. Sheesley concluded by discussing next steps.

Council Member Campbell arrived here, at 12:43 p.m.

Discussion ensued regarding speed humps on arterial streets, school speed zone beacons, the Prairie Line Trail, the Municipal Dock, Citywide striping, 64th Street, Safe Routes to School, and pedestrian safety near the entrance to Interstate 705 on 38th Street.

## **Other Items of Interest**

Council Member McCarthy stated he had recently attended a hiring event held by the Washington Hospitality Association where participants were able to find same day employment in the hospitality industry.

## **Committee Reports**

Council Member Mello stated the Puget Sound Regional Council Transportation Policy Board has recently updated performance measures in preparation for the next round of regional transportation funding.

Council Member Ibsen stated the Joint Municipal Action Committee recently discussed interlocal coordination of land banking and property surplus.
