Briefing Items

2. [17-0785](#) Safe Routes to School Update
[Jennifer Kammerzell, Senior Engineer, Public Works]

At approximately 4:41 p.m., Jennifer Kammerzell, Senior Engineer, Public Works, introduced Liz Kaster, Manager, Puyallup Watershed Initiative Active Transportation Community of Interest, and made opening remarks. Ms. Kaster began the presentation by providing the background information

of the Safe Routes to School (SRTS) implementation plan, including its history, numbers and location of accidents, data on students walking to school, SRTS action plan kickoff, and community and stakeholder outreach.

Ms. Kammerzell provided information and highlights related to the SRTS action plan, including the equity aspects, engineering, safety and equity analysis, 2017-2019 comprehensive SRTS pilot, education, encouragement, enforcement, and evaluation.

Ms. Kaster concluded by presenting the program tool kit and reviewed the additional elements of the SRTS plan and next steps.

Discussion ensued regarding the point of contact, involving the Joint Municipal Action Committee, encouraging safe routes, annual audit and budget, the need for identifying the budget process and timeline, enforcement, targeted schools, and the need for identifying and committing to improve more schools in Tacoma.

Public Comment


Public comment was heard from Anna Gizzi, 4116 North 19th Street, speaking on Safe Routes to School.
