At approximately 10:14 a.m., Amy McBride, Arts Administrator, Community and Economic Development (CED), introduced Mike Sweney, Tacoma Arts Commission Chair and discussed the current art events taking place throughout the City and the art and economic impact study that showed an increase in arts economic growth within the City by 50 percent.

Ms. McBride presented current development taking place around the City including Alma Mater, McKinley Lofts, and Birdloft Studio. Ms. McBride then presented the Culture and Transportation Plan for the Theater District, Theater District Artwalk, Public Art Public Action and arts community engagement events that took place in 2017.
