# PUBLIC HEARINGS AND APPEALS

William T. Lynn representing the appellant David Smith appealing the recommendation of the Hearing Examiner on the request to vacate a portion of the alley between East 28th and East 29th Streets, between Portland Avenue and East R Street, abutting and adjacent to Puyallup Tribal property, for a new multi-level garage structure, casino, hotel, and restaurant. Mayor Strickland called on William T. Lynn, representing appellant David Smith.

Mayor Strickland then called on John H. Bell, representing intervenor Puyallup Tribe of Indians.

Mayor Strickland then called on William T. Lynn for his rebuttal.

Mayor Strickland then called on Deputy City Attorney Martha Lantz, representing the City of Tacoma.

Mayor Strickland opened the appeal for questions from the City Council.

#### REPORTS BY THE CITY MANAGER

City Manager Pauli reported on June 6, 2017, the City Council approved \$3.4 million in funding to support the City's Temporary Emergency Aid and Shelter Plan and the allocation of these funds will support the implementation of two non-consecutive mitigation sites and one stability site through the end of this year. She stated the first mitigation site located at Portland and 18th Street is scheduled to begin transitioning individuals to the stability site on June 26, 2017, and the second mitigation site location has not been determined. She stated the stability site, which is located on City-owned property at 1423 Puyallup Avenue, will be operational on June 26, 2017, to provide an alternative location for individuals from the Portland and 18th Street mitigation site and other individuals experiencing homelessness. She then provided an update on the outreach efforts underway and stated staff has also set up a page that is accessible from the City's website which provides information on the Temporary Emergency Aid and Shelter Plan, frequently asked questions regarding this effort, and weekly media updates.

#### COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Council Member Ibsen, Vice Chair of the Infrastructure, Planning and Sustainability Committee, stated on May 10, 2017, the Committee received an update on the implementation of the Bring Your Own Bag Ordinance and the Environmental Services strategic plan. He reported on May 24, 2017, the Committee received an update on historic demolition review, and the Tacoma-Pierce County solid waste management plan and solid waste contract extension. Finally, he stated on June 14, 2017, staff presented the 2018 amendments and planning work program, as well as an update on the Foss Stormwater Sediment program, and the Committee selected Colin McCann to fill an opening on the Sustainable Tacoma Commission.
